TERMS & CONDITIONS

- 1. Application/Tender form can be obtained from our Fin. Deptt. or download from CCIwebsite www.ccilted.in by depositing DD or cash deposit through Bank in CCI A/c No. 30307670044 SBI Rajban of Rs.50/-
- 2. For Earnest Money Deposit (EMD) of Rs.3840/-(Rupees Three Thousand Eight Hundred Forty only) in shape of DD in favour of Cement Corporation of India Ltd.. Payable at SBI Rajban or can be deposit in cash in CCI Bank A/c No. 30307670044 SBI Rajban & receipt can be submitted with tender. Later on this amount will be considered as security deposit for the successful tenderers. However, the balance amount required as per rules on account of security deposit of Rs.10,000%-(Rupees Ten thousand Only) will also be adjusted from the monthly bills. CCI, such security amount shall not carry any interest.
- 3. Tender/Application without earnest money will not be entertained.
- 4. Tender/Application should be submitted in sealed cover duly marked on top Application FOR CYCLE/SCOOTER SHED/STAND CONTRACT along with due date on the envelope.
- 5. The presence of contractor/his representative will be round the clock (i.e. 24 hrs. In all the day)
- 6. In case of any theft or loss of cycle/Scooter bike etc. the contractor will be held responsible & recovered the same amount from the bill.
- 7. The Application/Tenderers should be land Outsee only whose land has been acquired by CCI for Factory/Mining purpose. A documentary proof in respect of the same should also be attached with the application tender from.

- 6. The contractor is expected to see the site of work, condition of approaches before tendering no claim what so ever shall be entertained by the Corporation later on after submission of tender.
- 9. The contractor has to submit the experience certificate or copies of work orders in support of having executed the similar type of job from reputed organization if any. The details of jobs executed & jobs in hand must be written in Annexure-C of the tender documents. The tenderer who will not submit the above documents shall not be considered and their techno commercial bid shall be out rightly rejected.
- 10. The contractor shall have to follow at the rules & regulations of Labour Laws as enforced by the State Government & Central Government from time to time.
- 11. The tender shall produce a credential/character certificate from a gazette Officer or Village Pradhan/Sarpanch.
- 12. The contractor shall submit bills every month for jobs carried out by him. After checking the bills by the incharge of the section/department regarding successful completion of work & after certification from concern dealing hand about payment to labours, payment will be made within 15 days to the contractor/ However, no claim or compensation shall be entertained if payment of bill is delayed due to any reason.
- 13. Labour payment is to be made by the contractor as per contractor labour (Regulation & Abolition) Act, 1970. If the contractor fails to make timely labour payment, the Corporation as a principal Employer shall arrange for the same. However, penalty @5% shall be deducted on this account from contractor's monthly bill.
- 14. The contractor shall not sublet the work without written consent of CCI.
- 15. The contractor's workmen must observe the Rules & Regulation of the Corporation in and outside the working area.
- 16. All Safety norms should be followed strictly by contractor. And night stay arrangement made by contractor itself at his own cost.
- 17. The Corporation will not be liable for any compensation towards any loss to the contractor on account of non-availability above of fronts or services due to reason beyond control of the Corporation.
- 18. In case the contractor abandon the work before the completion of the contract period or falls to do the work to the satisfaction of the CCI Management, the Corporation will be forced tom get the work done from other agencies on the risk & cost of the contractor. Besides, the SD will also be forfeited at the discretion of the Management. The Corporation shall also be entitled to be deducted the amount payable from any amount otherwise due to the contractor under this or any other contract.
- 19. The Management reserves the right to terminate the contract by giving one month's notice without assigning any reason what so ever.
- 20. The Management also reserves the right to terminate the contract without any notice if the contractor is found including in malpractices.

- 21. The contractor shall pay his workmen the wages not less than the minimum rates of wages as fixed by the Government of HP from time to time. The contractor shall also issue wage slip to his workmen at least a day prior to disbursement of wages.
- 22. The contractor will be ensure payment of wages to his workmen by 7th of every month by online payment from the Corporation & obtain a certificate as a proof of having made the payment of workmen. The contract will submit photo copy of payment sheet in receipt of attendance and wages paid of its workmen to Time Office every month without which the bills for the current month will not be forwarded. In case the contractor fails to make the payment to its labour repeatedly, the contractor shall be divided for future award of any work in the Corporation at the discretion of the management.
- 23. The workmen employed the contractor shall not be below the age of 18 years and beyond the age of 58 years. Further, no female will be allowed to work between 6.00 PM to 6.00AM.
- 24. The contractor shall be liable for compensation, to his labour payable under the workmen Compensation Act 1923/Employees State Insurance Act,1948 any other Act in case of accident. In case his fails to pay the compensation, the Corporation reserves the right to make the payment and recover from any of his bill or security deposit.
- 25. In the event of any question, dispute, breach or difference arising in respect of the meaning and scope of Terms & Conditions herein above, the decision of the General Manager will be final and biding to all and in case of any dispute with the decision of General Manager, Rajban Unit, it will be subject to the jurisdiction of Court at Paonta Sahib only.
