## PART-III (SPECIAL TERMS AND CONDITIONS)

1. The License will be given for the two years w.e.f..... 2023 which can be extended further for another year subject to satisfactory performance of the licensee, be mutual consent in Writing. However, the premises will be inspected by Committee nominated by the Management, if required, in case the committee is not satisfied with the cleanliness of the area, equipment, services, stuff and quality of the material being sold by shopkeeper, the license will be cancelled with a months' notice during the period of license. No notice will be placed in case performance is not satisfactory during the said period.
2. That the minimum monthly license fee is restricted upto Rs. 4000/- (Rupees Four Thousand only) plus GST as applicable both for shop and residence will be charged and separate bill will be raised in the starting of the month. The license fee of each month will have to be deposited by 10<sup>th</sup> of subsequent month.
3. The electricity charges will be on actual basis of meter reading on commercial rates. The electricity charges are to be paid by the licensee within 10 days from the date of receipt of the bill failing which an additional 10% surcharge will be levied and in case of default for the consecutive months, the supply will be disconnected.
4. The license shall not in any way assign rights or carry out any business other than for which the license is granted or employ or take the assistance of any one whose names are not approved by the company.
