


### **PART-III (SPECIAL TERMS AND CONDITIONS)**

#### **TERMS & CONDITIONS:**

1. The contractor has to submit the experience certificate or copies of work order in support of having executed the similar type of job form reputed organization if any. The details of jobs executed & jobs in hand must be written in Annexure-A of the tender documents. The tenderer who will not submit the above documents shall not be considered and their techno commercial bid shall be out rightly rejected.
2. The bill of courier services rendered shall be submitted on month to month basis by the party along with acknowledgements of letters/parcels delivered by them and shall be paid within 15 days on submission of bills through RTGS after deduction of TDS and other of any.
3. The contractor shall not sublet the work without written consent of CCI.
4. The Corporation will not be liable for any compensation towards any loss to the contractor on account of non-availability above of fronts or services due to reason beyond control of the Corporation.
5. In case the contractor abandon the work before the completion of the contract period or falls to do the work to the satisfaction of the CCI Management, the Corporation will be forced to get the work done from other agencies on the risk & cost of the contractor. Besides, the SD will also be forfeited at the discretion of the Management. The Corporation shall also be entitled to be deducted the amount payable from any amount otherwise due to the contractor under this or any other contract.
6. The Management reserves the right to terminate the contract by giving one month's notice without assigning any reason what so ever.
7. The Management also reserves also reserves the right to terminate the contract without any notice if the contractor is found including in malpractices.

**8. Dispute Under this contract and Arbitration: -**

- 9.1 In the event of any question/dispute breach of or difference arising in respect of the meaning and scope of terms & conditions herein or in connection with any matter under this agreement (except for those matters which are to be decided as per provisions made in these terms & conditions) the same shall be referred to GM of CCI Ltd. Rajban For appointment of a sole Arbitrator. There will be no objection if the Arbitrator so appointed is or was an Employee of the corporation and whether he had at any time in discharge of his duties as an Employee had expressed views on all or any of the matter in dispute or difference or dealt With matter in substance. The Arbitrator shall give award with reasons in respect of each claim, dispute or difference referred to him in the event the value of the dispute(s) exceeds Rs.50,000/-. The award of the Arbitrator shall be final and binding on the parties to this Contract.
- 9.2 Subject to aforesaid the Arbitration and Conciliation Act, 1996 the rule made there under any statutory modifications thereof for the time being in force shall apply to the arbitration proceedings under this clause.
- 9.3 The work under this contract shall be continued uninterrupted during the pendency of the Arbitration Proceedings and no payment due from one to the other parties therein shall be withheld on account of pendency of such Proceeding unless such payment related to the matters under Arbitration.
- 9.4 The venue of the Arbitration shall be Rajban or such other place as the Arbitral Tribunal at his discretion made determined.
- 9.5 All matter connected with this shall be governed by the Indian Law both substantive and procedural, for the time being in force and shall be subject to the jurisdiction of Indian Courts at Paonta Sahib (HP).
