#### **1. Introduction :**

Cement Corporation of India Ltd (CCI) was incorporated in the year 1965 as a wholly owned Government of India Undertaking with the principal objective of setting up cement factories in Public Sector to help achieve self-sufficiency in cement production and to remove regional imbalances in pursuance of the National Policy.

#### **2. Secretarial Auditor Proposed to be Appointed :**
