Sub: APPOINTMENT OF AGENT FOR HANDLING, CLEARING,
TRANSPORTATION AND UNLOADING OF CEMENT AT
NTPC, BARH FROM FATUAH RAILHEAD.

This is to inform that we understand that M/s. NTPC, Barh, Super Thermal Power Project, Barh is a potential customer and they have substantial quantity of cement requirement on a regular basis throughout the year for their on going construction activities. Recently we have been able to procure one rake load order from the party for F.O.R. delivery at their NTPC stores at Barh. The party was persuaded to accept cement at Fatuah Railhead but they did not agree to our request and asked to deliver at their site store as being done by the other private suppliers. In view of the requirement of the party and also considering the potentiality of the party for a regular requirement in future, we propose to appoint regular H&T Contractor at Fatuah initially for a period of 6 months with an approximate quantity of 16500 MT (i.e. 2750 MT approx), for taking delivery of cement rake from Railways, unloading from rake, loading into trucks, transporting from Fatuah Railhead to NTPC, Barh and unloading the material at party's Godown and obtaining receipt from the party regarding delivery of cement in good condition. This will help us to handle the material and delivery to NTPC smoothly without any hindrance. For this purpose we are enclosing a draft NIT for publishing the same in the local newspapers at Patna, along with additional terms and conditions specially approved by Corporate Office, in addition to the other terms and conditions of tender as per Corporate guidelines.

It is further also requested to kindly advise concerned to put the tender enquiry on CCI website for smooth access to the potential parties willing to participate in tender.

ADDITIONAL SPECIAL TERMS AND CONDITIONS

1. QUANTITY:

Approx.16500 MT (i.e.2750 MT approx.) 5-6 rakes in Six months

2. JOB DESCRIPTION:

- i) To take cement delivery from the Railways at Fatuah
- ii) Unloading cement from Railway wagon and stacking at Railway siding
- iii) Loading into trucks and transportation from Railway siding, Fatuah to NTPC, Barh Godown and unloading and stacking in party's Godown.

3. EMD:

Rs.28000/- in terms of DD in favour of Cement Corporation of India Limited, payable at Hyderabad.

4. DEMURRAGE:

Any demurrage and wharfage is to be borne by you in case of any delay. The contractor shall be responsible for the safety of cement lying in his custody till the same is delivered to the party.

5. PAYMENT:

Payment of above contract shall be made within seven days after completion of job through RTGS by above mentioned office on producing bill complete in all respect such as receipt of cement in good condition by the party (NTPC, Barh).

6. Transporting Agent (Contractor) shall keep contacts and collect delivery particulars from CCI office.
7. The Contractor shall lift the cement from railhead as per the rules / timings specified by them on working days and arrange deliveries at the destinations of consignees according to delivery schedule / terms and conditions.
8. The Contractor shall obtain clear acknowledgements from the consignees (NTPC, Barh) to whom cement is delivered regarding receipt of material in good condition.
9. The Contractor shall be responsible for the safety of the materials lying in his custody till the same is delivered to the party i.e. NTPC, Barh.
10. The Contractor shall be responsible to arrange proper storage of cement, in case of necessity, at his own cost.

11. The Contractor shall be responsible for covering the goods being cleared, stored and transported from damage / transport risk any other kind of losses. The execution of contract will be done under the supervision of CCI officials.
12. The Contractor shall ensure that the cement is delivered immediately after the date of instructions of delivery. In case of any delay or complaint from party, suitable penalty shall be imposed as decided by the Corporation.
13. The Contractor shall be liable to pay damage to Corporation in the event of any damage / loss caused to the cement till the time of delivery to the buyer / destination (NTPC, Barh). To avoid damage / loss to the cement in transit the contractor shall indemnify the Corporation full cost at market rates of the prevailing price of CCI's cement, whichever is higher.
14. It will be responsibility of the Contractor to ensure that there is no pilferage / damage / adulteration to the cement in transit. In case any of this is noticed, contractor will be held responsible and will have to compensate the Corporation as per the decision of the Corporation. However, in case of pilferage / adulteration, the penalty will be double the cost of cement.
15. Octroi, if any, will be paid by the Agency and same will be reimbursed by us on production of original receipts
16. You have to deposit Cash Security Rs.150000/- (Rupees One Lakh Fifty Thousand only) and furnish a Bank Guarantee / FDR of Rs.1000000/- (Rupees Ten Lakhs only) from any Nationalised Bank / Scheduled Bank. The SD/BG/FDR would be refunded within a period of 10 days after satisfactory completion of work. No interest on SD/BG/FDR would be payable.
17. **VALIDITY:** F.O.R. Six months i.e. upto September 2013.

The offer will be valid for a period of minimum 15 days from the date of issue of this Work Order.
