PROPOSED SCOPE OF WORK

The scope in general is briefly provided below for the understanding of the Firms / Companies / Agencies to enable them to submit their Expression of Interest (EOI)

- i) Review of sanctioned scheme of CCI (SS-06) and its evaluation / implementation in the present context.
- ii) Fresh valuation of all the Non-Operating units i.e. assets & liabilities.
- iii) In depth study of each unit on technical / financial viability for its revival or otherwise.
- **iv)** Proposed various models / strategies for revival / rehabilitation through JV Public private partnership or any other mode.
- v) Alternatively in case revival is to be taken up by CCI on its own, bankability of such proposals looking into assets / liabilities
- vi) Road Map for CCI looking into opportunities & potential of the organization for optimum utilization of its resources in operating & nonoperating units.
