For Providing the **Cloud hosting services for Tally ERP 9.**

This tender contains Part-I and Part-II general terms, Part-III special terms and conditions and price bid.

Please visit our website <u>www.cciltd.in</u> for Covering letter, Part-I - Instruction to tenderers, Part-II- General Terms & conditions, Integrity pact, all formats and submit the same & Annexere-9 duly filled and signed along with the tender.

In addition to the General terms & conditions of the tender under Part I & II, the following additional specifications and special conditions will also apply to the contract. These special conditions given below, if contrary to any conditions given in Part I & II, shall prevail thereon.

1. Scope of work :

- The Service Provider shall be responsible for providing Cloud services (24 x 7 x 365) throughout the contract period.
- The Service Provider shall responsible for configuring of hardware and deployment of tally ERP 9.
- The Services Bidders should provide the configuration with latest Gen hardware, load balancing support and latest Windows 2019/2022 with legal Antivirus.
- Regular Daily incremental backup and Weekly Full backup is to be provisioned with retention period of 3 years. Any time back up may be asked by CCI and Cloud service provider has to provide on the same day.
- Admin Console access to the server should be provided to the CCI.
- Web portal to be provided for Tally ERP 9 Application user access control. Also option to restricting/allowing Tally ERP 9 the user to a particular PC/Device or no of connection from single PC.
- Separate export folder to be provided for taking data from tally ERP 9.
- In case the successful bidder abandons the work or fails to execute the work or work is not satisfactory, then CCI may cancel the work order by giving 30 days notice.

2. Eligibility Criteria :

The Bidders should provide the following documents towards meeting the following eligibility Criteria of the tender.

3. Service Level Performance and penalty:

A. The average availability of the Server and application shall be at least 99.5% in a Quarter.

- **B.** Reports for performance, monitoring / usage to be submitted by the service provider on quarterly basis.
- **C.** Uptime Calculation: Uptime shall be calculated as (Total Time Down Time) X 100 /Total Time. Deduction in payment will be made for downtime in the quarterly bills raised by the CSP.
- **D.** The response time for attending the faults will be 1 hour after they are reported to the Cloud Service Provider. The CSP will rectify the faults within 4 hours. The services shall be provided 24 X 7 days in a week.

Downtime due to the following situations will not be considered for the purpose of penalty:

a) Due to schedule maintenance by the service provider, with prior approval from the company

4. TIME FRAME:

The work is to be completed within a time frame of 30 days from the date of the Award of Contract.

5. PAYMENT TERMS :

(a) Payment terms: Payment will be made at the end of every quarter equivalent to 1/4 of the annual contract value within 15 days of submission of bill subject to satisfactory performance.

(b) All statutory deduction will be made like TDS–IT & TDS GST

(c) GST amount will be reimbursed after upload invoices by the party in their GST portal & payment of Tax & submission of proof of the same.

6. DURATION OF CONTRACT :

The period of contract is initially for a period of one year from the date of issue of work order and the same can be extended for a further period of one year at the discretion of CCI.

7. SECURITY DEPOSIT :

Successful tenderer(s) shall have to furnish a security deposit equivalent to 5% (five per cent) value of the order calculated on landed cost basis i.e. basic price plus taxes, duties & freight by way of demand draft/bank guarantee (as per CCI"s format to be provided by respective unit) in terms of Clause 2 of Part II of the tender documents towards satisfactory performance of the contract. Security deposit is to be submitted at respective unit. SD will be released within 3 months after completion of work.

8. LIQUIDATED DAMAGES:

In case of any delay in services, Liquidated damages @ 1/2% per Fortnight of the value of

undelivered portion or part thereof to maximum of 5% shall be recovered. Also we may resort to risk purchase.

9. CONFIDENTIALITY:

The Bidder shall maintain strict confidentiality of all the documents, information, data coming in possession of the Bidder as a result of awarding the contract and also any oral, written or other information disclosed for evaluation or for any other purposes shall be considered as confidential information passed on to the bidder. The Bidder should certify in writing that the design of any document being printed / processed for Corporation is not used / shall not be used by the Bidder for any other Organization / entity under any circumstances. Any violation of the same will be liable for action under the law, which shall entitle Corporation to claim damages apart from taking action under the appropriate Law

- **10.** Any drop in the charge/tariff of cloud service during the contract period shall be passed on to CCI. However if there is any increase CCI will not pay that increase. No escalation of rates is allowed during the contract period and extended period.
- **11.** Any increase in Cloud Services needed by CCI in future would be on pro-rata basis. However, CCI shall place the order for required additional Cloud Services as and when required by giving a written request to the tenderer.
- **12.** No other charges would be payable by CCI.
