Terms & Conditions :-

1. The contractor shall provide a brand new white colour Honda City V CVT car in, Model 2022 (brand new) in showroom condition on 24 X 7 basis. The car and needs to be well maintained during the contract period.
2. The Lease contract would be for a period of 05 years.
3. CCI reserve the right to take one additional car on need basis. In case additional vehicle is taken by the Corporation as per need basis, the monthly lease rent shall be the same as offered in Annexure-A.
4. The vehicle shall remain in possession of CCI 24X7 and will be parked in the premises as directed by CCI.
5. The vehicle shall be insured comprehensively and CCI's name shall be included as lessee in the registration certificate (RC) of the vehicle. CCI will not be responsible for any loss damage or accident to the vehicle or to any other vehicle or injury. Firm will be responsible for all statutory compliance.
6. All statutory liabilities, arising out of any legal dispute, accidents, breakdown etc. shall be borne/paid by the Bidder/Firm / service provider.
7. Firm/service provider shall provide an equivalent car during break down/servicing/repair of car for more than 24hrs. A Penalty of Rs. 1,500/- per car per day shall be imposed if the transporter fails to provide car.
8. The leased car must have all relevant documents like registration book/insurance / Road tax receipt/ Pollution certificate, etc. The vehicle should conform to all Govt. rules and regulation being in force from time to time. The agency shall always keep CCI indemnified against any liability due to non-compliance of statutory obligation by the agency.

9. Payment Terms

The leased rent shall be paid on monthly basis. The agency shall submit bills, in duplicate, within the first week of each month to the Administration department, complete in all respects. Payment will be released within 15 days from the date of submission of the bill. TDS and other taxes as applicable shall be deducted from the bills of agency.

Manager (Admn.)

1. Scope of work :

- a. The scope of work involves providing a brand new Honda City V CVT car registered in Delhi/ NCR in WHITE colour (in showroom condition)excluding fuel charges and excluding driver, for a period of 60 months on lease basis.
- b. The tenderer will quote for the monthly lease rental charges taking into account the price of car, prevailing road tax, registration charges applicable for Delhi NCR excluding Driver and cost of fuel.
- c. The entire expenses towards leasing formalities shall be borne by the tenderer. Normal running of car by CCIL shall be about 2000 k.m. per month. The car shall be used mostly in Delhi NCR by the officials of Cement Corporation of India Limited (CCIL) and on requirement, shall be used for outstation tours as well. After conclusion of the contract, the car shall be handed over to the bidder. The cost towards any type of major / minor maintenance, tyre, and battery replacement, all kind of repairs/replacement, cost towards accidental damage, insurance, RTO charges, shall be borne by the bidder.
- d. The anticipated mileage for 5 years lease is 120000km The bidder shall be paid extra @₹4/km over and above 120000km.
- e. The cost on fuel and driver shall be borne by CCIL.
- f. The car shall be in Possession of CCIL on 24x7 basis.

- 2. Eligibility Requirements:** The tenderer should have valid PAN and GST number pertaining to this particular service. The tenderer should have carried out at least one work of leasing/Hiring of Car in Govt./ PSU or Private Organizations during the last eight years i.e. from the period 01.04.2013 onwards or a work order of hiring taxis with PSUs with a value of ₹4 lakh. The tenderer shall submit proof of execution of such work along with tender document.

3. Final Evaluation of the Tender:

- a. The evaluation shall be on the basis of net cost to CCIL excluding GST.
- b. The tenderer is advised to quote Lease rent Charges alongwith applicable GST. In the absence of tenderer quoting applicable taxes the rates shall be presumed to be inclusive of all applicable taxes. The payment shall be made to the tenderer after making recoveries towards applicable taxes. (TDS at applicable rates).
- c. The quote which costs the minimum to CCIL will be declared as successful L-1 bidder.

4. Period of Contract :

The Contract period shall be 60 months and would start from the date of start of Leasing service, which will be mentioned in the Work Order. At the end of term and after the conclusion of the Contract, the car shall be handed over to the successful tenderer, on as is where is basis. No counter claim on CCIL shall be entertained for any impairment of the car whatsoever.

5. Termination of Contract:

If at any stage during the contract, the successful tenderer:

- a) Tenderer commits any breach of the terms of this lease agreement / tender document or
 - b) In the event of unsatisfactory service or failure on the part of the tenderer at any time, to carry out the terms and conditions of the lease agreement to the satisfaction of CCIL, CCIL reserves right to terminate the contract without any further obligations.
6. If there is a change in the name / composition of the successful tenderer's firm / company's etc arising out of merging / collaboration with some other company or for any other reason, whatsoever, or, if any change takes place in the proprietorship or partnership of the successful tenderer's firm, the agreement shall be binding on the new entity. CCIL should be intimated within 30 (Thirty) days of such changes, failing which all payments may be withheld.

7. Jurisdiction :

This contract shall be deemed to have been entered into at Delhi NCR and all cause of action in relation to the contract will thereof be deemed to have risen within the jurisdiction of the Delhi Govt.

8. CCIL reserves the right to reject the notice of invitation to this tender without assigning any reasons.
9. The tender is liable to be disqualified, if :
- (a) tender is not submitted in accordance with terms and conditions stipulated in tender document.
 - (b) Tenderer changes his quoted prices during the period of validity of the quotation or its extended period, if any.
 - (c) tender is incomplete and / or received after the due date and time.
 - (d) information submitted found to be incorrect / false at any stage during the processing / evaluation.

- (e) it comes to the knowledge of CCIL that some tenderers have formed a cartel and resulting in delay / holding up the processing of tender. In such case, all the tenderers forming cartel as per the knowledge of CCIL, shall be further liable to be disqualified for a further period of two years for any tender floated by CCIL
- (f) the tenderer has been disqualified by any PSU / Govt. / CCIL at any time in the past for supply of services referred to in the tender.
- (g) If any employee of your firm / organization had any relations with CCIL.

SPECIAL CONDITIONS OF LEASING / HIRING OF CAR

1. All expenses involved in minor / major repairs, servicing, maintenance and normal wear and tear including expenses towards damage due to accidents scheduled and unscheduled repairs and maintenance will be borne by successful tenderer. The cost of fuel, toll parking and driver shall be borne by CCIL.
2. CCI's name shall be included as lessee in the registration certificate (RC) of the vehicle. CCIL shall sign the standard lease agreement containing above terms with the successful bidder. All expenses towards registration, leasing and getting the name of CCIL as lessee shall be borne by the tenderer.
3. The Car will be exclusively kept at the disposal of the Officers-in-charge of CCIL and will be used according to his direction during the period of contract. The travel may cover to his work place / inspection sites outside Delhi NCR also. The vehicle will be parked at the CCIL specified places the bidder shall have a right to inspect the car on monthly basis with prior intimation to CCIL. Any loss towards thefts of car or any part of the car shall be claimed by the tenderer directly from the insurance firm and CCIL shall not be responsible for any loss towards any such theft.
4. The successful tenderer shall undertake the complete repair and maintenance jobs viz., door / window jamming, non-functioning of Air-conditioning / Stereo and breakdown services of the car as well as providing alternate replacement by same model of car during the period of such repairs and maintenance.
5. During the period of breakdown / repair, when car is off road for more than 24hrs, the bidder tenderer shall also provide with a substitute car of same segment. If the tenderer fails to provide the relief car the penalty of Rs 1500 per day during the period car remains off the road shall be levied. CCIL shall be within its rights to make alternative arrangements by hiring another car of equivalent brand from any other source and the amount so spent, together with any other reasonable incidental charges etc. will be fully recovered from successful tenderer's regular bills.
6. The bidder will take due care for servicing the car as specified by manufacturer and shall keep the car always in perfect condition. In case the successful bidder fails to do the essential repairs / routine maintenance as specified, CCIL will get it done at the risk and cost of the successful tenderer.
7. In case of accident it will be the successful tenderer's responsibility to get the job attended including tin work and painting and no extra charges will be paid by CCIL to the successful tenderer.

- 8.** The car shall be fitted with all accessories as provided by the Manufacturing Company including Music system and the same shall be maintained in working conditions by the successful tenderer during the Contract period. In case of any of such accessory becoming faulty / stolen the same shall be repaired/replaced by the successful tenderer at his own cost. In case of default the same shall be done by CCIL at risk and cost of tenderer.
- 9.** The car may have to travel to outside Delhi also on certain occasions. For such movements the payment shall be as per the existing terms only.
