# CEMENT CORPORATION OF INDIA LTD. (A GOVT. OF INDIA ENTERPRISE) PART – III : SPECIAL TERMS & CONDITIONS

In addition to the General Terms & Conditions of the tender under Part-I & II, the following Special terms & conditions will also apply to the contract. These Special terms & conditions, if contradictory to any conditions given in Part-I & Part-II, shall prevail upon the conditions given therein:

- Eligibility Criteria : Railway Siding (Line No-1) Exchange Yard at CCI-Mandhar, District Raipur, Chhattisgarh will be given to the actual users only. Bidders are required to submit a Certificate along with techno commercial bid certifying that they will use the Railway Siding – Exchange Yard at Mandhar for their actual use only, failing which the tender is likely to be rejected.
  - 1.1 The Bidders should have logistics experience of 2 years in handling of bulk goods via Rail/Road. End users transporting their own goods via Rail/Road shall also be considered. Bidder as an entity should have minimum turnover of Rs.2 crores during last 3 years.
  - 1.2 The bidders are requested to visit the CCIP Mandhar railway siding before bidding, particularly on or before 18.04.2022 (10.00 AM to 5.00PM) i.e., before 'Pre-Bid Meeting', to ensure its workability, suitability etc. about the siding, on later stage the CCI will no way be held responsible in any way on any such matter(s),
- 2. Bidders will have to submit their detailed proposal to the concerned railway authorities, to obtain their unconditional No Objection for use of our railway siding at Mandhar to facilitate inward and outward traffic for their goods. However, if CCI wants to use of its Railway Siding for inward/outward traffic during the currency of contract period it will have the overriding right to use the same.
  - 2.1 The railway siding is non-functional for last twenty years and the current railway track condition is not suitable for starting siding operation immediately without maintenance of civil work, track work, OHE work, signaling and techno-communication work. Apart from above, the prospective bidder has to get No Objection Certificate (NOC) NOC from concerned Railways, from the local Gram Panchayat, Pollution Control Department where ever is applicable.

The successful bidder has to complete the entire maintenance work of the siding on his own cost, to make the siding operational as per prevailing Railway norms and has to obtain NOC from the respective offices/Deptts. In addition, the Railway dues against the CCI Mandhar siding is to be confirmed by the party which is Rs.12.39 lakh + GST Rs.2.23 lakh as per letter dtd.23.09.2021 of Railway, and has to pay the entire Railway dues including interest if any.

2.2 Before submission of tender, the tenderer may get total maintenance charges confirmed from Railway including OHE maintenance as per Railway maintenance norms, and Railways dues, as applicable, and visit and inspect the siding/track conditions on their own cost and interest.

Any claim whatsoever will not be considered /entertained by CCI in this regard, at any stage. The total maintenance charges shall be borne as per actual by the successful Bidder(s). In case of more than one co-user the maintenance charges to be borne by sharing in proportion to their allocated numbers of rakes.

2.3The successful tenderer will also not have any right to sub-lease the Railway Siding to any other party without any written permission of CCI.

# 3. Bidding / MAR :

- 3.1 The Monthly Minimum Assured Revenue (MAR) shall be Rupees Twelve lakh (Rs 12.00 Lakh) payable per month for handling up to forty-five (45) numbers of rakes quarterly (three months) excluding GST. The number of rakes allowed quarterly shall be 45 rakes per quarter and additional rakes above 45 numbers of rakes per quarter will be charged on prorate basis.
- 3.2 The Monthly Assured numbers of rakes will be considered on quarterly basis i.e. for three (3) months period basis. As such for three months period total 15x3=45 numbers of rakes will be allowed. Additional rakes beyond 45 numbers of rakes handled in three consecutive months i.e. in a quarter will be considered for charging additional on pro-rata basis. (For example, : if finalized MAR value per month is supposed to be Rs.18 lakh per month for 45 numbers of rakes per quarter then for the additional rakes beyond 45 numbers of rakes in a quarter will be charged at Rs18x3 lakh divided by 45 rakes(per quarter) = Rs1.2 lakh per additional rake beyond 45 numbers of rakes handled per quarter.). The numbers of unutilized rakes in one quarter will not be carried forward for the next quarter. The three months period will be counted from the date, of start of MAR charging.

3.3 The MAR shall start either from 90 days of issue of Work Order/LOI or fifteen (15) days from the date of grant of permission (NOC) from Railways, or from the date of starting siding operation by the successful bidder, whichever is earliest.

3.4 Mobilization/Siding-maintenance period: 90 days period will be allowed for Mobilization, Siding-maintenance and obtaining NOC, etc. from Railways, in normal circumstances.

3.5 Rental increment: There will be increment in rental charges @ 10% per annum on basic finalized MAR, which will also be applicable over additional rakes rental charges, on pro-rata basis.

- 3.6 Only one co-user will be awarded the contract.
- 4. Cement Corporation of India Ltd., will permit the successful tenderer to use CCI railway siding at Mandhar and for this purpose the party will have to pay one month's final allocated work value in advance by 5<sup>th</sup> of each month. In case, the payment is not received on due date, interest @ 2% per month on outstanding amount shall be charged for delayed period. However, CCI reserves the right to terminate the lease to use the railway siding at any time with two-month notice.
- 5. The successful tenderer will also have to pay the fixed charges such as Railway Land Rent, maintenance charges, Inspection charges of private siding, establishment

charges of S.E. Railway Staff and any other periodical charges payable to the Railway for using the railway siding etc. as per actual to Railway Authority within due date and provide the acknowledgement of such payment to CCI, Mandhar. In case of more than one co-user the maintenance charges to be borne by sharing in proportion to their allocated numbers of rakes.

- 6. All indents will be raised by the successful tenderer directly on the Railways for the rakes under intimation to CCI-Mandhar and their payments will be made directly by the party to Railways under intimation to CCI-Mandhar against each rake.
- 7. Compliance of all the local laws will be responsibility of the successful Bidders. It will also be their responsibility to seek prior clearance from all the appropriate authorities.
- 8. The tenderer will also ensure that there is no violation of laws/regulations while using the CCI railway siding. In case any penalty is imposed while using the CCI's railway siding the same will have to be borne by the tenderer.
- 9. The tenderer will be solely responsible for ensuring the implementation and compliance of labour laws or any other legal laws affecting the engagement of labours. - 12. In case CCI has to pay any demurrage/wharfage or any other charges to Railways due to blockage of track on account of the tenderer, the same will be paid by the tenderer to CCI immediately for making payment to Railways on rake to rake basis.
  - 12.1 The successful tenderer has to obtain No Demurrage Certificate from the Railways after each rake and to submit the same to CCI before handling of the next rake.
  - 12.2 In case of any damage to the track, for any reason, damage to the property of the Corporation, the successful tenderer/party will be responsible and will be liable to rectify/repair all the damages caused by them/their representative. No relaxation in such circumstances will be entertained on any account.
- 14. Earnest Money Deposit:- Submission of Earnest money of Rs.2,00,000/- (Rupees two lakh only) through e-Payment (through e-tendering portal Gateway). - 23. **Penalty** : After the award of the Tender, In case if the Bidder backs out, disputes the payment terms, do not adhere to or do not comply to the tender terms and conditions, as well as any action of the party liable to the breach of the contract, the S.D. as well as Advance deposited shall be forfeited.

In case of revenue losses caused by any of the co-user by not clearing the loading platform in due time, creating hindrance to other co-users or any act of co-user which will cause losses, such co-user will have to indemnify CCI. Such losses will be recovered from such party(s). Decision of CCI in this matter will be final and binding.

#### 24. Force Majeure conditions

24.1 If at any time during the continuance of the agreement/contract, it becomes impossible by reasons of war, or war like operations, strikes, lock-outs, riots, civil commotion, epidemical sickness, pestilence, earthquake, fire, storm or floods, the contractor shall during the continuance of such contingencies, not be bound to execute the contract during this period as per agreement/contract time schedule. The work shall be resumed immediately the contingencies has have ceased or otherwise determined and contractor's obligations shall continue to be in force for correspondingly extended period after the resumption of execution. The contractor shall however, inform the Corporation by registered post about such acts at the

beginning and end of the above causes of delay within ten days of occurrence and cessation of such force majeure conditions.

- 24.2 In the event of delay lasting over one month, if arising out of cause of force majeure the Corporation reserves the right to cancel the order/contract without any compensation whatsoever, and/or any consequential loss etc.
- 24.3 Only events of Force Majeure which affect the work at the time of its occurrence shall be taken into cognizance. The Corporation shall not be liable to pay any extra costs or increased rates due to delay under Force Majeure conditions. Only appropriate extension of time will be granted.

# 25. JURISDICTION:

25.1 It is hereby agreed by the parties here to that only Courts at New Delhi/Delhi shall have jurisdiction to decide or adjudicate upon any dispute which may arise out of or be in connection with this agreement.

# 26. LAWS GOVERNING THE CONTRACT:

This contract shall be governed by the laws of Union of India in force.

### 27. NOTICE:

- 27.1 Any notice hereunder may be served on the contractor by Registered Post/Mail at his last known address. Proof of issue of any such notice at his address shall be conclusive proof of having received the notice by contractor.
- 27.2
  - a. Form of Notice: All notices, demands and communications between the parties must be in writing.
  - b. Method of notice: The parties shall give all notice, demands and communications between the parties by (i) personal delivery (ii) first class registered or certified mail, postage prepaid, return receipt requests. All notices, demands and communications to the party shall be given at the last known address of the party.
  - c. Receipt of Notice: A notice , demand and communications given under this contract / Agreement will be effective on :
    - i) The other party's receipt of it, or
    - ii) If mailed, on the earlier of the other party's receipt of it and the fifth Business Day after mailing it.
  - d. Proof of issue of any such Notice at the last known address of the party shall be conclusive proof of having received the Notice.
- 28. In case, the payment is not received on due date, interest @ 2% per month on outstanding amount shall be charged for delayed period.

- 29. The party shall directly be responsible for all or any dispute arising between him and his employees and keep the Corporation indemnify against all loss, damages & claim arising thereof.
- 30. The party shall all the times indemnify CCI against,
  - a) All claims and damages CCI may face or incur due to any direct or indirect act or omission and / or any violation / breach, of this contract or any Law, Rules, Bye-Laws, Notifications or Directions issued by Central, State or Local Authorities, and /or due to any action or negligence on the part of the party in general, AND
  - b) With respect to all claims, demands causes of action, obligation, litigation, liability, loss, damage, cost and expenses incurred or sustained by the corporation at any stage i.e., either during the period of contract or expiry of contract, caused due to poor maintenance / performance of the railway track in particular.
  - 31. CCI may terminate this contract at any time after giving Two month notice of termination to the party, if :
    - a) The party fails to perform, has made or makes any inaccuracy in, or otherwise breaches, any of its obligations, covenant, or representations,
    - b) If the party violates any of the terms and condition stated in the contract.
    - c) If the party becomes insolvent, bankrupt, or enters receivership, dissolution, or liquidation,
    - d) If there is or becomes any Law that makes the performance of the terms of this contract illegal or otherwise prohibited, or any Government Authority issues an Order restraining or enjoining the transactions under this contract.
    - e) If the H-1 bidder fails to execute the contract or backs up, the parties H-2, H-3 . . . and so on may successively be offered the contract by matching the H-1 rate.
