#### 03. SUITABILITY FOR BLASTING WATERY HOLES :-

Cap Sensitive Explosives must be in cartridge form and most suitable for blasting watery drill holes with high efficiency.

## 04. QUALITY:-

Supplied Explosives should be free from all defects, such as, those arising out of use of defective materials or any manufacturing and other defects.

## o5. QUANTITY:-

The quantity to be transported is 120 MT of Emulsion/Slurry Base Explosives (83mm dia), 80,000 Mtr. of Detonating Fuse (10gm/mtr.) & 5000 nos. of Relay (17MS) ( $\pm$  20%).
