01. GUARANTEE/EFFECTIVENESS :-

Supplied explosives must be of such grade & strength that it must produce most effective blasting result at least upto 6 (Six) months from date of receipt of consignment at our site.

02. SENSITIVITY :

It must be of such quantity that must attain desired sensitivity and produce most effective blasting result.

03. SUITABILITY FOR BLASTING WATERY HOLES :-

Cap Sensitive Explosives must be in cartridge form and most suitable for blasting watery drill holes with high efficiency.

04. QUALITY :-

Supplied Explosives should be free from all defects, such as, those arising out of use of defective materials or any manufacturing and other defects.

05. QUANTITY:-

The quantity to be transported is 120 MT of Emulsion/Slurry Base Explosives (83mm dia), 80,000 Mtr. of Detonating Fuse (10gm/mtr.) & 5000 nos. of Relay (17MS) ($\pm 20\%$). However, the quantity may vary depending upon the requirement of the Corporation. The contractor shall not be entitled to make any claim whatsoever on this account.
