## 01) **GENERAL**

### 1. Scope of Work:

- 1. Engaging of one JCB with backhoe loader along with driver for removal of spillage materials around various locations of coal mill, preheater, kiln & cooler.
- 2. Diesel, spares etc., have to be arranged by the contractor at his cost.
- 3. The contractor should ensure that the JCB engaged is in healthy & working condition, to avoid any breakdown during the operation.
- 4. The contractor should engage his JCB in specified area to remove the material as per instruction of CCI representative.
- 5. Workmen's compensation Act and other statutory laws in this connection i.e., Insurance of his employees against accidents etc are in his own interest (by contractor). Corporation is not responsible for any accident etc to the workmen or any damage to JCB etc. engaged by the contractor.
- 6. While working at site proper care should be taken to avoid the damage to the property of CCI and incase, occurrence of any incident to any person of CCI or damage to the property of CCI, all the expenditure should be borne by the contractors and CCI is not responsible for the same.
- 7. All insurance coverage should be arranged by the contractor for JCB, and driving license to driver should be submitted before commencement of work and the driver should show the same at any time to the officials of CCI during his working time.
- 8. The contractor and his men should comply rules of safety and security prevailing at CCI premis
- 9. The contractor has to adopt all measures for providing safety equipments for safe working of his employees inside the factory. All the labours engaged by the contractor for the above work should wear personal protective equipment.
- 10. The contractor shall ensure that no person should be engaged for the above work who is below the age of 18 years or has attained the age of 58 years.
- 11. The contractor is fully responsible for safety of his equipment as well as the properties of Corporation.
- 12. In case of non-execution of work / job as per work order, CCI reserves the right to get the work done by engaging other agencies at your risk & cost.

#### 2. Quantity: 42 Hrs

- 1. Engagement of JCB as per the daily requirement of CCI tandur. The use of the loader will be on need and utilization based only depending upon the requirement on that particular day. The hour meter reading will be considered for arriving at the total hours of pay loader worked per day. The break down period will not be counted and Corporation will not pay any amount either for the break down period or for the alternative arrangement made in case of breakdown of the loader.
- 2. For payment purpose, the actual Running Hours of the JCB worked for the job will be taken into account. In the event of hour meter of JCB not working/not available at any time during its operation, the working hours will be recorded manually by CCI till the hour meter is repaired /arranged and it will be considered for payment.

However, quantity may vary more or less and for such variation no any claim of contractor will be entertained. Work is to be executed as per the instruction and requirement of Mechanical Department.

3. Eligibility Criteria: Experience in same work or ownership/authorization of vehicle (JCB)

## 4. Duration of Contract:

The contract is valid for 42 hrs from the date of Work Order/LOI and In case the work is not allocated due to any reason, the time period shall be extended accordingly. Party should engage the JCB immediately after placement of Work order.

# 5. Rate: Should be quoted in Rs/Hour

The rate quoted shall remain firm during the period of contract/and extended period of the contract from the date of award of work. GST applicable should be mentioned clearly in their price bid. If tax element is not separately mentioned in the price bid, it will be assumed that the rate offered inclusive of tax. No escalation in the rate after award of work order will be entertained during the period of contract / extended period. The contractor's quoted rate should be inclusive of labour rate, tools and tackles required for completion of tender work.

- 6. EMD: NIL
- 7. Security Deposit: NIL
- 8. Payment: 100% Payment will be released by way of RTGS after submission of the bills for the work completed. Paying authority is HOD (Fin).
- 9. Income Tax will be deducted from the bill as per IT rules & GST-TDS will be deducted as per GST rules. Any other taxes as per Income Tax Act or GST Rules or Amendment as applicable shall be liable to be deducted under a specific act if applicable.
- 10. The tenderer shall enclose copy of PAN CARD along with the offer.
- 11. GST amount will be reimbursed after submission of proof of uploading the GST invoices and amount in GST portal.
- 12. <u>ARBITRATION</u>: All disputes in case value exceeds ₹50,000/- will be referred to Arbitration as per Indian Arbitration Act. Arbitrator has to be appointed by C&MD of CCI.
- 13. JURISDICTION: Vikarabad Dist, (Telangana State) Civil Courts.
