In addition to the General Terms and conditions of the tender Part- I & II the following Special terms and conditions also apply to the contract for the supply of above category of material. ## 1.0 GENERAL TERMS & CONDITIONS:

- 1) Supply, supervision of erection and commissioning of CT & PT will be under the scope of supplier.
- 2) Detail specification of all the individual accessories and components make, rating and other data should be provided with drawing.
- 3) List of panel mounted item with make and type etc, should be provided with drawing.
- 4) Digital input and output, Analog input & output should be provided as per standard norms of the panel
- 5) Party should submit the work order in support of experience certificate wherever they supplied the same/related or above rated CT & PT.
- 6) The tenderer should quote the item rates in accordance with items mentioned in the PRICE BID format.
- 7) The rates should be inclusive of all taxes, etc. where applicable, and shall be on firm quotation basis and shall be valid till the allotted work of CT & PT is completed.


