SCOPE OF WORK AND TERMS & CONDITIONS FOR :

Service engineer for vibration checking/inspection/rectification at Raw Mill-1 HT motor foundation.

1.0 SCOPE OF WORK:

- a. Reduction of abnormal vibration in motor foundation.
- b. Rectification in existing base of old motor by the best procedure of civil engg. works of RCC foundations. Extension & Straitening the base as per the motor frame.
- c. Fabrication of new base frame for new motor (BHEL Make). The new base frame thus fabricated & installed should be identical & common for both motors i.e. old & new. The motors should be inter changeable with the new base frame in future after these works.
- d. The new modified foundation after best civil engineering works completion by party should ensure that there is no any adverse impact on original RCC foundation and have the best quality to meet the standards of civil foundation design.
- e. Drawing development for base frame.
- f. GA with foundation load data.
- g. Detail technical specification of foundation, new base frame.
- h. Detail engineering services like preparation of fabrication drawing alignment etc.
- i. Motor base frame (machined) supply mechanical engineering and documentation.
- j. Civil work as per Clause No. 6.0.
- k. Supply of foundation base board as per requirement of new base.
- 1. Satisfactory trail run after completing the new base frame, alignment etc.
- m. Any other materials if required as per job to be provided by party

2.0 ERECTION AND COMMISSIONING:

2.1. **Steel, equipment & piping fittings**:- All steel and pipe fittings, any other required materials for fabrication will be under the scope of party.

2.2. **Consumable**:- All the consumables like Gas (including gas cylinders) and welding rods will be in parties scope. This also includes any special type of welding rods. All welding and cutting tools like welding machines, cutting sets, welding cables etc. required for work will be in parties scope.

2.3. Lifting and shifting machine:- By overhead crane of CCI.

3.0 SUPERVISION SERVICES:-

(Mechanical erection and electrical installation)

3.1. Lodging provided by CCI and fooding will be in parties scope.

- 8) The Corporation will not be liable for any compensate on towards any loss to the contractor on account of non-availability of fronts or services due to reason beyond control of the Corporation.
- 9) In case the contractor abandon the work before the completion of the contract period or fail stood the work to the satisfaction of CCI Management, the Corporation will before to get the work done from other agencies on theirs & cost of the contractor.
- 10) The Management also reserves the right to terminate the contract without any notice if the contractor is found indulging in mal practices.
- 11) The Corporation shall not be responsible or liable for any cred it facilities extended by the contractor to any of his customers.
- 12) All instructions, which shall be issued to contractor by Engineer in- charge of Bokajan Cement, Factory shall be deemed as part of the contract.

6.0 CIVIL WORKS:

6.1 Foundations of raw mill-1 and necessary civil works shall becarried out by the party. The dimensions of the foundation and anchor bolt pits etc. to be fixed accordingly and shall be checked by the contractor for their correctness as per standard. Further top elevation of foundations shall be checked with respect to benchmark etc. All minor adjustments upto 25 mm or desired as per site requirement of foundation level, dressing, chipping of foundation surface enlarging the pockets

infoundations and grouting of sole plate / bolts etc. as may be required for the erection of motor shall be carried out by the Contractor. All the materials like cement, sand, gravel etc. and cleaning consumables shall also be arranged by the contractor at his cost. The required special cement like CONBEXTRA-GP2 and SHRINKOMP N 30 etc. or its equivalent grade cement for grouting of base frame, equipment's etc. shall be arranged by the contractor at their cost. The contractor should also arrange required nos. of mixing machines and vibrators at their cost.

6.2 The contractor shall ensure perfect matching of packing plates with foundation by dressing the foundation and between the packing plates and the base plate of structural column/equipment. Also party should ensure no vibration of motor as per ISI standard. Tools (Accredited by NABL or similar agencies) and machining/matching of packing shall be carried out by the Contractor at his own cost.

6.3 The contractor shall arrange the GA drg./foundation lay out for grouting of foundation bolt holes of equipment and final grouting of equipment as per the drawings / specification after preparing the foundation surface for grouting.

6.4 The contractor at his own cost shall arrange for grouting of anchor points of T & P issued to him and also grouting of winches or any other supports required for T & Ps. Necessary grout materials are to be arranged by the contractor at his cost.

7.0 <u>SCOPE OF MATERIAL HANDLING AND SITE STORAGE AND OTHER</u> <u>RESPONSIBILITIES</u>:

7.1 The work covered under this scope of work is of highly sophisticated nature requiring best quality / precision workmanship engineering and construction management. He should also ensure successful and timely commercial operation of equipment installed. The contractor must have adequate quantity of precision tools, construction aids in possession. Contractor must also have adequate trained qualified and experienced supervisory staff and skilled personnel.

7.2 All the necessary certificates and licenses required to carry out this scope of work are to arranged by the contractor then and there at no extra cost.

8.0 DRAWINGS AND DOCUMENTS:

8.1 The detailed drawing specification to be made accordingly as per scope of work/present job/foundation for raw mill-1. These documents will be made available to the contractor during execution of work at site.

9.0 Tools & Tackles:

9.1. The party at his own cost shall arrange all tools and tackles, manpower required for taking up the jobs as per scope of work given in Annexure–C of part IV.

9.2. Office space within the plant premises will be provided by CCI to parties for office work and storage for tool and tackles.

10.0 DURATION OF CONTRACT/COMPLETIONOF WORK:

The work shall be completed within 12-13 days from the date of receipt of the work order. However, in view of the urgency you shall complete the job as early as possible.

11.0 LIOUIDATEDDAMAGE:

Liquidateddamages for delay in delivery shall be levied at the rate of ½% (Half percent) per fort night or part thereof, for the late delivery against time mentioned in each job order, subject to a maximum of 5% of thevalue of hat joborder. The Corporation will however, not be bound to prove that it has suffered to the liquidated damages claimed.
