**PART- III: Re-babbling of White Metal Bearing Liners of Raw Mill H.T. Motors as per drawing nos. (Raw Mill-11:51:06)”.**

**1.0 SCOPE OF WORK:**

- 1) Removal of Old babbed metal from the shell in controlled Electric Furnace or any other method without affecting the base metal of the bearing.
- 2) Cleaning and De-greasing of the bearing.
- 3) Tinning with pure tin.
- 4) Babbling of Bearings by centrifuging process with virgin Lead free Tin base White metal conforming to IS 25 Grade 84.
- 5) Finish machining of bore to required size as per drawing.
- 6) Add 10mm more metal after machining at bore of bearing shell.
- 7) In every set = 02 halves (Top & bottom) bearing supporting end hole in bottom halves to be make metric threaded type and 04 nos. of L-key bolt (12mm x 80mm) size to be provided in every set, which should not touch in bearing casing while those bearing will be fitted in both end shaft. Cracked top halves bearing supporting end hole to be make properly by filling material / drilling / threading etc.
- 8) Checking/ testing of white metal bond ultrasonically for 100% bonding conforming to BHEL specification AA0850126.
- 9) Dye Penetrate test on the surface and joints for Pinholes, inclusion and cracks etc. as per BHEL specifications AA0850126.

**2.0 CERTIFICATES / TEST REPORTS:**

You will submit the following along with delivery of the bearing –

- a) Test Report of White metal tested from a Govt. recognized Laboratory.
- b) Ultrasonic and DPT Report.
- c) Test Report of Dye Penetrant .
- d) Dimensional Inspection Report.
- e) Guarantee Certificate.

## **COMMERCIAL:**

### **3.0 TRANSPORTATION :**

To and fro transportation of bearings will be arranged by tenderer. The tenderer has to unload and load the bearings at their end. Alternatively it has to be arranged by the tenderer as per the rate finalized including unloading and loading the bearings at their end.

### **4.0 GUARANTEE :**

The re-babitted bearing liners are to be guaranteed for any manufacturing defects of re-babitting towards the material used and workmanship for a period of **one year** from the date of commissioning or **18 months** from the date of delivery whichever is earlier. Any defect/failure found during the above period shall be rectified by you free of cost including transportation charges.

**5.0. EMD:** N/A

**6.0. SECURITY DEPOSITE:** N/A

### **7.0 PAYMENT TERMS :**

90% payment shall be released within 30 days after deduction of Income Tax and works Tax (TDS) after successful trial run of the motor/bearing and balance 10% after completion of guarantee period.

### **8.0 GENERAL CONDITIONS:**

- (i) Test Certificates from a Govt. recognized laboratory for material composition, ultrasonic test and DP test, dimensional inspection reports and guarantee certificates to be submitted.
- (ii) Delivery- F O R - CCI, Bokajan Unit (transportation for both end will be parties scope)
- (iii) Inspection – Inspection shall be carried out by CCI engineer at our works after receiving the material before dispatch of material. All necessary instruments/arrangements for inspection shall be provided by you.



## **9.0 DURATION OF CONTRACT / COMPLETION OF WORK:**

The work shall be completed within 04 to 06 weeks from the date of receipt of worn out bearings at your works. The rates to be quoted should be exclusive of all taxes applicable. All applicable taxes i.e. GST etc. should be mentioned separately. Under this contract the prices shall remain firm throughout the tenure of the contract i.e. for a period of one year. If taxes and duties are payable extra, the same should be clearly indicated. The contract can be extended for another one year at the same rates & conditions at the discretion of CCI Ltd.

## **10.0 EXPERIENCE:**

The tenderer should be well experienced in the line of work under consideration. The tenderer should furnish documentary evidence such as Xerox copies of work orders executed by him for the past 2 years in Public Sector/reputed Private Sectors Units for the work of similar nature. Certificate for satisfactory performance of the work issued by them also can be considered. The tenderer should have required personnel, machinery, and insured go down, financial soundness so as to be competent and capable for the job under consideration.

## **11.0 DELIVERY:**

In normal cases, repaired/rewind bearings should be delivered back within 04-06 weeks from the date of receiving from CCI. However, in case of urgency, the repair/rewinding work shall be carried-out within lesser time, at the discretion of CCI in special cases depending upon the quantum of work involve for the delivery.

## **12.0 LIQUIDATED DAMAGES :**

Liquidated damages for delay in delivery shall be levied at the rate of ½% ( Half percent) per fortnight or part there of the late delivery against time mentioned in each job order, subject to a maximum of 5% of the value of that job order. The Corporation will however, not be bound to prove that it has suffered to the liquidated damages claimed.

## **13.0 TAX :**

- a) Should submit GST certificate. GST amount will be reimbursed on the basis of GSTR-2A report. In case non-filing of GSTR-1 return or wrong filling, the amount equivalent to GST will be deducted from party.
- b) Should submit PAN of firm/company.
