The detailed specifications are given in annexure VI.

In addition to the General Terms and Conditions of tender under PART – I & II, the following terms and conditions will also apply to the contract. These special terms and conditions, if contradictory to any conditions given in PART – I & II, will prevail upon the conditions given therein. In addition to the above, the following will also apply.

1. PAYMENT TERMS

1.1. No advance payment shall be made.

1.2. **90** % of the contract price including 100% GST as applicable will be released within 30 days on its receipt of LRS at site & certification by CCI officials after the supply of the complete LRS along with requisite accessories etc at site.

1.3. Balance **10%** of the total contract prices (excluding GST), will be **released after deduction of L.D.& other recoveries, if any** on successful completion of warranty, for a period of 12 months with a claim period of 03 months.

1.4. In case the problem in LRS within the warranty period, the supplier will depute his representative within 07 days from the date of intimation by the CCI for joint inspection. In case the failure is due to the reasons attributed to supplier, the LRS will be replaced /repaired by the supplier within 15 days from the date of joint inspection.

1. Objective: - Procurement of Liquid Rotor Resistance starter for Cement mill Starting duty application (150 KW, 415V, 1500 RPM SLIP –RING INDUCTION MOTOR, ,RV/RA-568V/160A, Motor Pull Out Torque (% FLT) = 250 %, APPLICATION Compressor) which shall be Motorised / Manually operated suitable for following Slip-Ring induction motor and having starting and running interlocking arrangement and having suitable cable entry box and having S.S. (304Q) Electrodes in horizontal movement and having shorting contactor of (AC3 duty of "Siemens/ L & T make) in delta connected.

- 2. Technical Specification of Motorized as well as manually operated Liquid Rotor Starter (for starting duty):
- 1. The Electrolyte tank shall be floor mounting, free standing type, dust & vermin Proof construction and shall be made-out by 6 mm thick S.S. sheet steel.
- 2. Inside the electrolyte tank Epoxy coating shall be provided.
- 3. Polypropylene Phase Barriers shall be provided.
- 4. Movement of Moving Electrodes shall be Horizontal type.

5. LRS shall suitable for two consecutive starts from cold & four starts per hour equally Spread in hot conditions.

6. Limit Switches for Interlocking purpose with Spares contacts shall be provided on terminal plate with marking and ferruling.

- 7. The Fixed & Moving Electrodes having horizontal movement will be made out by 6 MM S.S. (304Q) sheet steel .
- 8. Electrolyte filling & over flow sockets will be provided.
- 9. Air Break Power Contactor of 250Amp rating will be provided (in delta connected) to suit R.A (Rotor amps) of motor for final short-circuiting the resistance. **When motor attains full speed.**

10. Control Panel of suitable size will be provided which Consisting of RDOL Starter of suitable rating Aux. Contactor for reversing & forwarding Pilot Motor & the Moving electrodes, Over Load Relay, Manual Selector Switch, Push button, MCB, Indicating Lamps and Power/Control TBs etc.

11. suitable rating of 3-phase, 415volts 50 Hz, Pilot Motor of Squirrel Cage type BBL, ABB, Siemens, Kirloskar, CGL make will be provided.

12. All control supply shall be from control transformer 415VAC/ 220VAC, all indication shall be 220 VAC. Siemens/L&T make Switch-gear components shall be provided in LRS.

13. The Electrical Interlocking circuit will be provided. The Interlocking is such

that the Main motor cannot be started unless resistance is in fully "IN" position

& the Main motor will be tripped, if the Electrode does not reaches to run position within specified time.

14. The control panel and LRS will be Epoxy painted by Light Grey IS631.

15. Electrolyte level indicator shall be provided.

16. Digital PH indicator for PH value shall be provided on control panel.

17. LRS shall have a Re-circulating pump (Kirloskar make) for mixing electrolyte with separate control circuit (pump will running after motor stop for 20 mins and provision of manual start is also available on control panel.

18. Party shall submit G.A drawing and control scheme along with their technocommercial bids.
