For Godown prices, the element of packing & forwarding charges should be indicated specifically otherwise, it will be taken as NIL & in case of extra, the same shall be payable as per actual limited to 2%.
05. Please indicate your GST Regn. No. In absence of this information your firm will be treated as an unregistered firm and your prices will be loaded accordingly.

13. **DELAYED DELIVERY CLAUSE:** In case of any delay in the delivery (a) You will be charged with the Liquidated Damages @ 0.5% of the value of the un-delivered portion per fortnight or part thereof, maximum up to 5% of order value on landed cost basis. (b) Also we may resort to risk purchase as per clause 9 given below.
14. **RISK PURCHASE CLAUSE:** In the event of delay in supplies or failure to supply of material, CCI will have the rights to purchase the materials at the Risk and cost of supplier.
15. **ARBITRATION:** All disputes in case value exceeds Rs.50,000/- will be referred to Arbitration as per Indian arbitration Act. Arbitrator to be appointed by C&MD of CCI.
16. **JURISDICTION:** Paonta Sahib, Distt. Sirmour (HP) Civil Courts.
17. **GUARANTEE & WARRANTY:** The material offered against this tender has to be guaranteed for satisfactory working for a period of 18 months from the date of supply. The supplier shall warranty to replace/rectify or repair – free of cost at the factory site, the component or part of the items proved to have become unserviceable out of any of the above defects to materials with a period of 12 months from the date of use of materials or 18 months from the date of dispatch, whichever’s earlier. In the event of the suppliers not complying with the above within reasonable time the Corporation will have the option to rectify/repair or replace the defective parts after giving 3 weeks’ notice to the supplier and recover the cost from the supplier.

SPECIAL TERMS & CONDITIONS OF CONTRACT

TENDER FOR ANNUAL RATE CONTRACT FOR DISMANTLING/ERECTION OF 1600 H.P, 11KV SYNCHRONOUS INDUCTION MOTORS INCLUDING COUPLING AS PER SCOPE OF WORK AT RAJBAN CEMENT FACTORY.

1. **Terms of Payment:** 90% payment after deduction of applicable taxes shall be made within 30 days after completion and satisfactory trial of equipment/motor at our site. Balance 10% shall be kept as security deposit towards performance guarantee to be Refunded after six months from the date of satisfactory work.
2. **EMD:- Nil.**
3. **Taxes: G.S.T as Applicable.**
4. **Transportation /Lodging and boarding :-** NOT applicable
5. **Duration of contract:** Two year from the date of award of work with one year extension subject to CCI management sole discretion. Work of motor replacement shall be completed within 2-3 days from the start of job as directed by HOD (Elect)/Section in-charge.
6. **Liquidated Damages:** L.D. will be levied @ ½% of the work value or part thereof for per day delay on unexecuted job, subjected to maximum of 5%.
7. **The contract will be subject to extension for equal period, if CCI deserve so on the same rates, terms and condition.**
8. **Jobs mentioned in Price Bid are to be done on specific instructions of CCI as or when required basis.**
9. **Corporation reserves the right to carry out the works on the risk & cost of the contractor from open market by tender or by any other mode in respect of such work that contractor fails to carry out in accordance with the terms agreed, after giving due notice to contractor.**
10. **Contractor shall be responsible of safe execution of job at site for shifting /erection/dismantling of motor as job required lifting and supporting work. In any case if any damage occurred to motor during the entire course of work , contractor shall be liable for the payment of motor repair cost what so ever reason may be.**
11. **CCI will Provide Pay loader subject to availability of machine , else contractor has to arrange his own tractor for the job for which no extra payment will be made.**
12. **Contractor shall ensure safe execution of work for both man and machine , if any Accident occurred at site Contractor shall be responsible for the same and no claim shall be applicable by contractor to CCI.**
13. **Contractor shall liable to attend breakdown immediately on call even in odd hours.**
14. **Safety of personnel will be the responsibility of the tenderer. All required PPE (Personal protection equipment) has to be provided by the Successful tenderer .**
15. **Employment card on form XIV (under rule 76) & Identity card with photograph duly signed by him with seal or his authorized agents signature which are subject to check by the Security officials of the Factory at the Main Gate while allowing them to work etc.**
16. **The contractor shall be responsible for proper observance of discipline by all the workmen employed by him. Any damage caused by any worker shall be deducted from the bill of the contractor.**
17. **Tenderer should ensure the timely payment to their workmen on or before 7th of every month without any deduction except statutory deductions.**
18. **Manpower Deployed by contractor/vendor/tenderer shall not be below 18 years & above 58 years or and shall submit all requisite age proof certificates in this regard viz. Aadhar card etc.**

20. In case of any dispute in regard to the contract, the jurisdiction shall be the court Of Paonta sahib.

1.0 SCOPE OF WORK

In addition to the General terms and conditions of the tender under Part –I, Part –II the following terms and conditions will also apply to the contract. These special terms and condition if contradictory to any condition given in part –I and Part –II shall prevail up-to the conditions given therein.

1.1 SCOPE OF WORK: (for 1600 HP, 11 KV synchronous induction motor)

- Decoupling of motor after taking Power shutdown from substation.
- Dismantling of pedestal bearings of DE side & NDE side Along with lubricating oil.
- Dismantling of exciter, Brush gear assembly after removal of Power termination/connections.
- Dismantling of stator & rotor of H.T motor.
- Removal of rotor from Stator to working platform.
- Removal of coupling after making necessary arrangement of jacks & pullers etc.
- Fixing of Coupling after making necessary arrangement for heating/oil bath.
- Lifting and installation of rotor inside stator.
- Positioning of stator & rotor on base frame with bearing liners.
- Associate manpower in alignment of stator and rotor which may require lifting/adjustment of rotor.
- Assembly of exciter and brush-gear assemblies.
- Associate manpower in both side bearing adjustments & power connection of motor.
- Fixing of side cover of motor & safety guard.(incase nut & bolts got damaged /shortfall same shall be arrange by successful tenderer free of cost)
- Successful Trial run of motor.
- **Shifting of spare rotor & stator (only in case of failure or at specific instruction of HOD (Elect) & for which arrange of hydra/crane shall be done by successful tenderer without any extra cost).** Tenderer may include cost of hydra in case required.

1.2 Above jobs is indicative, however if job required to be carried out for satisfactory work but not specified in 1.1 scope of work shall be in the scope of successful tenderer.

1.3 Tenderer shall bring his own specialized tools and tackles.

1.4 CCI shall provided Chain blocks, sling , d-shackle etc. for safe execution of job subject to availability.

1.5 Quoted by tenderer shall be as per motor/ job location considering all safety aspect no extra charge will be paid incase under estimation of quoted rates.

02. WORK SCHEDULE:

2.1 The complete work is as per scope of given above at our site will be within 2-3 days, as per specific instruction of HOD (Elect)/ Section in-charge, from the start of job (for normal condition) and in case of breakdown immediately .
