Part-III SPECIAL TERM AND CONDITIONS

1.0 ELIGIBILITY CRITERIA:

1.1 Only authorized dealers of Sleeves Make: MASTA/SIBCO/SCHAEFFIER/SKF shall be technically qualified. Non-authorized dealer and other make shall be disqualified.

2.0 QUANTITY:

2.1 The quantity indicated is tentative.

2.2 The actual quantity to be supplied shall be indicated through indents to be issued from time to time.

2.3 Non-acceptance of indents, as may be received from the CCI Rajban on monthly/quarterly basis as per CCI Rajban requirements, by the supplier on any account viz. Qty., delay in receipt of indents etc. will tantamount to breach of contract and supplier will be liable to pay penalty/LD as per decision of the corporation based on the relevant Para of the terms & conditions of the contract.

3.0 DELIVERY:

3.1 The indents shall be sent through email. Delivery shall be effective within 2-4 weeks of issue of indents. In case of urgency you have to supply within 3-7 days. The items are expected to be in ready stock.

4.Prices:

4.1 The discount offered on the prevailing price list shall be inclusive of packing and forwarding charges, freight, inspection charges and any other levies/ charges etc. and GST shall be extra. Necessary documents will have to be submitted by you for availing ITC on GST. The discount on prevailing price list shall be firm throughout the contract period or extension thereafter. Tenderers have to submit the price list duly signed & stamped by the MASTA/SIBCO/SCHAEFFIER/SKF.

5.0 PAYMENT TERMS:

5.1100% within 30 days from the date of receipt & acceptance of materials at our site after adjustment of recoveries due, if any as per CCI's assessment and L.D clause.

5.1.1 **LD:** In the event of goods not delivered on or before the date of delivery mentioned in the indent, a penalty @ ½% of the unexecuted order value per fortnight or part thereof shall be levied, subject to a maximum of 5% of total value of order.

5.2 in case of payment through bank, all bank charges shall be borne by supplier.

6.0 QUALITY:

6.1 Party is expected to supply the sleeves that are manufactured within 03 months of the date of placing of indents. The sleeves supplied shall be guaranteed for 18 months from the date of supply or 12 months from the date of use whichever is earlier. In case the sleeves found defective, the supplier shall replace the material immediately at free of cost.

7.0 DURATION OF CONTRACT:

7.1 The contract shall remain valid for placement of indents for a period of one year from the date of Letter of Intent. However, the validity period for placement of indents may be extended with mutual consent. In case of any outstanding quantity against the indents placed which have not been supplied within the contract validity period as per our schedule and to be supplied even beyond the period of contract, the validity period shall be deemed to be extended suitably to complete the outstanding quantity against the indent placed.

8.0 JURISDICTION:

It is hereby agreed by the parties here that only the following Courts shall have Jurisdiction to decide or adjudicate upon any dispute which may arise out of or be in connection with the agreement:-
