02. SENSITIVITY:

It must be of such quantity that must attain desired sensitivity and produce most effective blasting result.

o3. SUITABILITY FOR BLASTING WATERY HOLES :-

Cap Sensitive Explosives must be in cartridge form and most suitable for blasting watery drill holes with high efficiency.

04. QUALITY:-

Supplied Explosives should be free from all defects, such as, those arising out of use of defective materials or any manufacturing and other defects.

o5. QUANTITY:-

The quantity to be transported is 120 MT of Emulsion/Slurry Base Explosives (83mm dia), 80,000 Mtr. of Detonating Fuse (10gm/mtr.) . However, the quantity may vary depending upon the requirement of the Corporation up to \pm 25%. The contractor shall not be entitled to make any claim whatsoever on this account.
