04. **DELIVERY PERIOD**: -

07. **<u>QUALITY</u>**: -

In case the supplied materials / electrodes are found to be of sub-standard / poor quality or defective materials, it has to be replaced free of coast. For all such incidence, the matter will also be referred to your local head office (LHO) for suitable action. Electrodes of Latest manufactured dated should be supplied, so that the same can be used for maximum period used. Electrodes of latest manufacture date may please be supplied to facilitate us it use for ling period.

08. LIQUIDATED DAMAGES: -

Materials should be supplied within 15 days time on placement of our indents. In case of delay L.D. @ $\frac{1}{2}$ % per fortnight on Un-delivered quantity will be imposed subject to Maximum of Rs. 5 % of the Contract value.

"The IGST / CGST / SGST, if applicable, will be paid on the cost of the finished goods being supplied, as per the rate (%) prevailing at the time of scheduled delivery period, subject to the supplier claiming the same as a separate item on their bill.
