PART- III: Special terms and conditions for “Rewinding of electric motors upto 40HP”.

SCOPE OF WORK:

1. The motor will be dismantled and damaged stator/rotor armature/field coil etc., be stripped out properly with proper tools. Any further damage during the process shall be borne by the Tenderer.
2. Old copper winding should be completely removed from rotor and stator. Before start of rewinding of the motor, the stator and motor winding etc. will be inspected by CCI Inspector only after the clearance from CCI, the stator and rotor with coil repaired from fresh copper, rewinding work should be started. The rewinding will be permitted by fresh copper wire only.
3. The slots will be cleaned and prepared for laying of new insulation. No separate charges will be paid for dismantling and assembly after repair/rewinding.
4. The new stator/rotor/armature/field coil will be made with Finolex, Usha, HTP, ICC & Bangappa conforming to IS 4800-Part V latest super enameled copper winding wires, medium covering, suitable for class “F” thermal insulation and electrolytic copper strips of requisite IS specification with proper insulation, wherever required.
5. The old wedges are to be replaced by the new wedges of best quality Glass Epoxy lamination wherever applicable.
6. All the spare parts such as bearing, capacitors, Terminal blocks replacement of sheared bolts, bearing, cups, cooling fans, end covers, fan covers etc if found damaged and if required have to be replaced. However, CCI at its discretion may supply these spare parts or may ask the firm to replace these spare parts on actual cost basis to CCI. However, estimate will be submitted by the firm for the parts, which are found damaged.
7. Additional repair such as building up by welding and machining of worn-out seating of the shaft and bearing housing to the required size, repairs/replacement of Rotor/Shaft, repair of broken foot of the motors etc. if required shall have to be carried out. Estimate for these repairs also will have to be submitted by the firm and the Corporation at its discretion may ask the firm to carry out above repairs in consultation with its Engineer in charge. No change in the basic design of the winding of the motor, change in scheme of connections/size of conductors as compared to original shall be carried-out without the written consent of the Engineer in charge. The bearing should be cleaned and suitable grade of grease should applied on the bearing without any extra cost to CCI.

8. The winding should be varnished and thoroughly impregnated and coat of becketol red or grey, as per decision of CCI should be provided on the winding to reduce the chance of moisture absorption by the winding. Preferably Dr. Beck & Co. make varnish and Becketol should be used.
9. The terminal leads used for the motors must be annealed tinned conductor silicon rubber insulated, glass fiber braided, silicon varnished and proper voltage grade flexible cable of adequate capacity. Lugs/sockets/end terminals leads if not already there.
10. The tenderer should quote for rewinding with Class "F" insulation Standard ISI materials shall be used and insulation class "F" shall be used unless otherwise specified.
11. Rewinding shall be arranged as per the priorities mentioned in the job order.
12. To facilitate inspection by CCI's representative during rewinding/repairs, the tenderer must inform the Corporation in writing indicating the date when the motor is being taken for rewinding/repairs.
13. (a) Testing of motor should be done at each stage of repair/rewinding. CCI at its discretion may inspect the quality of the material, workmanship, progress of work at any stage.

(b) Load Trial- Successful tenderer has to arrange load trial for 8 hrs. continuous running of 40 HP and above sq. cage and all slipping motors either at their workshop or at CCI and including the report of testing.
14. No sub letting of work for rewinding /repair etc. will be done by the party and the jobs shall be done as per the prescribed procedure of the manufacturers.
15. After completion of the work including assembly, the motor will be offered for final inspection.
16. **Experience:** - The tenderer should be well experienced in the line of work under consideration. The tenderer should furnish documentary evidence such as Xerox copies of work orders executed by him for the past 2 years in Public Sector/reputed Private Sectors Units for the work of similar nature. Certificate for satisfactory performance of the work issued by them also can be considered. The tenderer should have required personnel, machinery, and insured godown, financial soundness so as to be competent and capable for the job under consideration.
17. Motor test report should be included after fresh rewinding of the motor and per phase load current and resistance should be balanced (+- 2% variations). Motor no load current should not be acceptable after 50% of full load.

COMMERCIAL:

1. TRANSPORTATION :

To and fro transportation of motors will be arranged by tenderer. The tenderer has to unload and load the motors at their end. Alternatively it has to be arranged by the tenderer as per the rate finalized including unloading and loading the motors at their end.

2. GUARANTEE :

- (a) The motor after repair/rewinding shall be guaranteed for a period of one year from the date of receipt at CCI plant or 6 months load trial of completed motor whichever is earlier. Any defect found during the above period shall be rectified by the party free of cost.
- (b) In case the motor fails within the guarantee period, to and fro transportation charges for re-repairing/rewinding will be borne by the Contractor.

3. EMD: N/A.

4. SECURITY DEPOSITE:

- (a) Successful tender(s) shall have to furnish a Security Deposit equivalent to @ 5 % (five percent) value of the order calculated on total value of order i.e. basic price plus taxes duties and freight by way of demand draft / bank guarantee from any nationalized bank (in CCI's format) in terms of clause 2 of part-II of the tender documents towards satisfactory performance of the contract. Security deposit is to be submitted at respective unit.
- (b) Security Deposit shall be released within three months after completion of supplies and acceptance of material by the respective unit.

5. PAYMENT TERMS :

90% payment shall be released within 30 days after deduction of Income Tax and GST-TDS after successful trial run of the motor and balance 10% after completion of guarantee period.

6. DURATION OF CONTRACT :

The Contract will be for a period of (01) One-Year, but subject to extension for a further period of One-Year with the same terms and conditions based on the performance of the contract and mutual consent of both the parties.

7. DELIVERY:

In normal cases, repaired/rewind motor should be delivered back within 02 months from the date of receiving from CCI. However, in case of urgency, the repair/rewinding work shall be carried-out within lesser time, at the discretion of CCI in special cases depending upon the quantum of work involve for the delivery.

8. GENERAL CONDITION :

- a. The contract shall be governed by the general conditions of Cement Corporation of India Limited as stipulated in part-I and part-II of the Tender documents. Your special attention is drawn towards the clause of Force Majeure conditions, non performance, arbitration etc., etc.
- b. CCI reserves the right to inspect at any stage the process of rewinding. In case it is found during the inspection that the old used copper winding wire has been used in place of new one as per the contract, the party will be Black listed along with the imposition of penalty besides forfeiture of S.D & E.M.D.
- c. Old copper generated from the rewinding process will be the property of the rewinder, as such the quoted rate shall be the indication of net after deducting the Salvage value of old copper rewinding wire.

9. LIQUIDATED DAMAGES :

Liquidated damages for delay in delivery shall be levied at the rate of ½% (Half percent) per fortnight or part there of the late delivery against time mentioned in each job order, subject to a maximum of 5% of the value of that job order. The Corporation will however, not be bound to prove that it has suffered to the liquidated damages claimed.

10. TAX :

- a) Should submit GST certificate. GST amount will be reimbursed on the basis of GSTR-2A report. In case non-filing of GSTR-1 return or wrong filling, the amount equivalent to GST will be deducted from party.
- b) Should submit PAN of firm/company.
