02. <u>VALUE OF THE CONTRACT</u>.

The tentative value of the contract will be around Rs. 20.00 Lakhs $(\pm 25 \%)$.

03. <u>DISCOUNT</u>: -

Maximum Rate of discounts on the Manufacturer's Price list may be indicated separately.

04. **DELIVERY PERIOD**: -

The Bearings will be supplied / delivered drawn on as and when required basis against indents placed. The Bearings are to be delivered at our stores at your cost, i.e. rates are to be quoted F.O.R. CCI Bokajan Basis.

05. <u>PAYMENT</u>: -

100 % Payment will be released within 30 days from the date of receipt of the bill and acceptance of the materials supplied through RTGS.

o6. **PERIOD OF THE CONTRACT**: -

The Contract will be for a period of (01) One-Year, but subject to extension for a further period of One-Year with the same terms and conditions based on the performance of the contract and mutual consent of both the parties.

07. **<u>QUALITY</u>**: -

In case the supplied Bearings are found to be of sub-standard / poor quality or defective materials, it has to be replaced free of cost. For all such incidence, the matter will also be referred to your local head office (LHO) for suitable action. Bearings of Latest manufactured dated should be supplied, so that the same can be used for maximum period used. Bearings of latest manufacture date may please be supplied to facilitate us it uses for ling period.

08. LIQUIDATED DAMAGES: -

Materials should be supplied within 15 days time on placement of our indents. In case of delay L.D. @ $\frac{1}{2}$ % per fortnight on Un-delivered quantity will be imposed subject to Maximum of Rs. 5 % of the Contract value.

"The IGST / CGST / SGST, if applicable, will be paid on the cost of the finished goods being supplied, as per the rate (%) prevailing at the time of scheduled delivery period, subject to the supplier claiming the same as a separate item on their bill.
