## Expression of Interest

The Bokajan Cement Factory is a unit of Cement Corporation of India Limited, under Ministry of Heavy Industries, situated at 21 Kms from Dimapur Airport & 350 Kms from Guwahati, under the District Karbi-Anglong, Assam. The production capacity of Bokajan unit is 600 TPD. The Bokajan Cement Plant has 02 Nos of Raw Mills having capacity 25 TPH each, 02 Nos of Rotary Kilns for Clinker production having capacity 300 TPD each, 02 Nos of Coal Mills for Coal grinding and 01 No Cement Mill having capacity 35 TPH for Cement grinding. To operate all the above mentioned plant machineries we require to handle different raw materials. The tentative quantity of raw materials to be handled annually and approximate operational distance to be cover by HEMM equipments to handle raw materials is tabulated hereunder:

S/N	Variety of Raw Material to be Handled	Tentative Quantity (MT)	Approximate Distance to Handle Materials (Mtr)
1.	Limestone	2,00,000	100-150
2.	Clinker	1,20,000	10-15
3.	Coal	36,000	50-100
4.	Fly Ash	15,000	30-40
5.	Gypsum	1,500	15-20

Apart from handling of above materials, one tractor with hydraulic trolley is required to handle necessary building materials, set materials and shifting of machinery equipments inside the plant & residential colony as per requirement/demand of the organization. The tentative distance may be covered per day by the tractor is around 1-3 Kms.

It is pertinent to mentioned that estimated quantity may be varied based on the performance of yearly production. Similarly, range of distance, which will be covered by tractor, may be varied as per requirement of plant/colony etc.

Expression of Interest is invited from interested parties having HEMM equipments (mainly JCB, Dozer & Tractor with Hydraulic Trolley) of its own or with proper undertaking having valid documents (like RC, Insurance and Pollution etc.) and not to be older than 03 years in operation. It is expected that party will carry out the entire above mentioned day-to-day handling job along with other required activities as and when required as per instruction of CCI-Bokajan Official's.

It is worth mentioning that all the expenses like fuel, lubricant and running maintenances etc. will be under the scope of contractor. The schedule maintenance and other breakdown cost will also be under the scope of contractor. During the schedule maintenance of equipments same type of HEMM equipments are to be provided by the contractor. The operator of HEMM/Tractor shall be provided by the contractor.

In general HEMM equipments shall be operated in general shift from 7.30 AM to 4.30 PM; however, as per corporation needs it shall be operated as and when required basis. The HEMM equipments (JCB, Dozer & Tractor with Hydraulic Trolley) will be hired for a period of one year with a provision of extension for another year at the same rate, terms & condition after satisfactory completion of contract by mutual consent.
