Registration:

#### PART-III

TERMS AND CONDITIONS FOR AUTO(FUEL) /AUTO (ELECTRIC) HIRING AT DILLAI PARBAT LIMESTONE MINES QUARRY.

- 01. Scope of Work/Place of Visit: The Auto Rickshaw is required to ply to Dillai, Hidipi, Zero Point and other surrounding areas of Quarry, Dillai Parbat Limestone Mines within 6 A.M. to 6 P.M.
- 02. <u>Security Deposit</u>: 5% of contract value will be retained toward S.D. subject to total value of contract. In the event of non-performance of the contract as per contract term or un-satisfactory performance, the Security Deposit will be forfeited wholly or partially as the case may be, at the discretion of the Corporation.
- Mileage: The running of the Auto should not be less than 16 KM / Ltr consumption of Fuel with 50 gms Mobil / Ltr of Fuel. Whenever Fuel charge is claimed, all the Cash Memos of the Fuel purchased during the claim period should be attached in support of the rate claimed. However the cost of Mobil will be reimbursed at the normal rate as available in the Petrol Pump.
- 04. **Requirement of Driver**: The tenderer may engage a Driver for running of the Vehicle. The Driver should have valid driving licence, pleasing personality and required knowledge of maintaining the Log Book in respect to place visited and K.M.s run etc.
- 05. **Period of Contract**: The Contract will be awarded for a period of two years. However, it may be extended for a further period of one year at the discretion of the Corporation at the existing rates terms and conditions subject to the satisfactory performance of the contract.
- 06. **Firm Rate :-** The rate at which the contract is awarded shall remain firm throughout the contract period and any extension thereof irrespective of change in labour rate, hike in vehicle spares and any change in Govt. Policy.
- 07. **Payment of Bill:** The bill should be submitted to HOD (Mines) /In charge(HR) on fortnightly basis. These bills will be duly verified by Controlling Officer within 7 days of submission and will be passed for payment.

# **Part-IV**SPECIAL TERMS AND CONDITIONS

- a) In the event of vehicle break down/repair etc. the contractor shall provide alternative vehicle with all valid document and driver at no extra cost to the Corporation over and above the approved rates.
- b) In case the contractor does not provide the vehicle during maintenance or break down of the vehicle provided the Corporation reserves the right to hire the vehicle from any outside agency and deduct any amount paid in excess from the bill of the contractor without any prejudice.
- c) The fuel will have to be arranged by the Contractor as per the contract terms. The contractor may be sanctioned advance for 15 days consumption of Fuel/Oil through the Controlling Officer who shall ensure that the fuel to be purchased by the contractor is strictly as per the records of running K.M. of previous fortnight and that the advance paid as such is utilized only for fuel/oil and the same is adjusted before second advance is allowed.
- d) The driver of the vehicle shall be required to maintain a Log Book as per direction of the Controlling Officer.
- e) The Km/Meter of the vehicle should always be in good working condition for tallying with the Log Book maintained. In case the meter showing Km is out of order the distance run shall be decided by the Corporation and contractor will have no right to raise dispute in connection with the Km's run by the vehicle. The owner of vehicle is wholly responsible towards its damage and maintenance thereof. The vehicle should be available in good conditions at all times. In the event of non-availability of the Auto for utilization by CCI due to contractor reasons pro-rata hourly deduction with penalty up to Rs.20/- per Hour may be levied at the discretion of the Management .The road worthiness of the vehicle will be decided by the Corporation.
- f) The vehicle owner, under no circumstances, will be allowed sublet the contract partially or wholly to any other agency without due permission of the corporation. In case of subletting of contract, the contract will be terminated with forfeiture of Security deposit.
- g) If any damage is caused to any property of the corporation or any injury is caused to or death occurs of any person while travelling in the vehicle or anywhere else due to any act of any person employed by the contractor or by his vehicle, the contractor shall be liable for such damaged/compensation in respect thereof and shall be indemnify the Corporation and kept the Corporation indemnified against all such losses, damages, costs, charges, expenses and all liabilities of whatsoever nature and kind which the Corporation may incur/sustain or be put to in consequence thereof or any reason of such damage, injury or loss of life.
- h) Force Majeure: -During Bandh or Civil Commotion etc., if vehicle is not provided due to such events pro-rata deduction will be made from the bill submitted for the day/hrs. for which vehicle is not provided at the gate.

- i) The Corporation reserves the right to terminate the contract without assigning any reason thereof.
- j) In the event of any dispute or differences, arising in respect of the meaning and scope of the terms and conditions therein contained, the same shall be referred to the sole arbitration of an Officer of the Cement Corporation of India Ltd. to be appointed by the General Manager, of this Unit.
- k) It is hereby agreed by the parties hereto that only General Manager shall have jurisdiction to decide or adjudicate upon any matter, which may arise out of or be in connection with these terms and conditions of the contract.
- l) It shall be the responsibility of the owner of the vehicle to deal in proper manner with the Officer or other employee of the Corporation.
- m) The owner of the vehicle shall be wholly responsible for any damage caused to vehicle or injuries caused to the Driver/any other person arising out of accident or dispute etc. with any third party.
- n) For the purpose of jurisdiction, only the Court at Diphu shall have the jurisdiction to adjudicate.
- o) Your tender would initially be entertain subject to the following, that
  - i) you must have posses valid PAN card & GST Registration;
  - ii) you must have a Bank Account in SBI Bank;
  - iii) your vehicle/Auto must have up to date Insurance coverage.
