#### 01) **SCOPE OF WORK AND RELATED CONDITION:**

- b) Field survey should be done by utilizing latest version of survey equipments. Survey equipments and other working aids have to be arranged by the Surveyor.
- c) All bore holes & blocks etc., should also marked clearly in the plans, sections and drawings as per the procedure laid down under the MMR 1961 & amendment MCDR 2019.
- d) Colour code may be used while preparation of plans & sections or any other statutory drawing required.
- e) Vehicle at site may be arranged by CCI for dropping at site for pick-up from there if available.
- f) Helpers for field survey max 02 (two) persons may be arranged by CCI as and when required if available.

- j) The work shall not be sublet by the contractor to any other party without the prior written permission of the Corporation.

#### 02) SUBMISSION OF UPDATED PLANS & SECTIONS:

After completion of field survey work & quarterly survey as mentioned above (S.No.1.1 to 1.4) in each quarter, the contractor will submit plans & sections of the mine in the following forms:

- a) All statutory Plans and Sections such as Surface Plan, Working Plan, Geological Plan, Water Danger Plan, Key Plan, Section Plans etc showing National Grid lines & the structures of all surface features 500 meters & 2 KM outside the lease boundary area as required by DGMS through MMR 1961, IBM through MCDR 2019 with latest amendments.
