GENERAL TERMS AND SPECIAL TERMS & CONDITIONS OF CONTRACT

1.0 SCOPE OF WORK:

- End termination of laying of 3 core x 240 sq.mm HT Cable (XLPE) in side existing cable trench and out door.
- CCI will provide end termination kits (heat shrink end termination)
- Tenderer shall bring his own specialized tools and tackles and manpower to execute the job.

2.0. Terms of Payment:

- No advance payment shall be made.

- 90% payment after deduction of applicable taxes shall be made within 30 days after completion of work & submission of invoice duly certify by HOD(Electrical).

2.1 **Security Deposit @ 10 %** of value of work order including all taxes shall be kept as security deposit & shall be released after six months.

3. **Documents required to be submitted along with offer:-** Signed & Stamped copy of GST Registration Certificate and PAN Card.

4. **Transportation /Lodging and boarding** :- In Tenderer scope.

5. **Periodicity of contract:** Validity of contract shall be one year from the date of award of work & work shall be completed as directed by HOD (Elect)/Section in-charge.

6. **Liquidated Damages:** L.D. will be levied @ ½% of the work value or part thereof for per week delay on **unexecuted** job, subjected to maximum of 5%.

7. **GUARANTEE:** The contractor/ Tenderer shall stand guarantee towards the workmanship for a period of six month from the date of satisfactory completion of work . Tenderer shall rectify any defect in cable laying during the above period free of cost.

8. **The contract will be subject to extension for equal period, if CCI deserve so on the same rates, terms and conditions.**

9. Corporation reserves the right to carry out the works on the risk & cost of the contractor from open market by tender or by any other mode in respect of such work that contractor fails to carry out in accordance with the terms agreed, after giving due notice to contractor.
