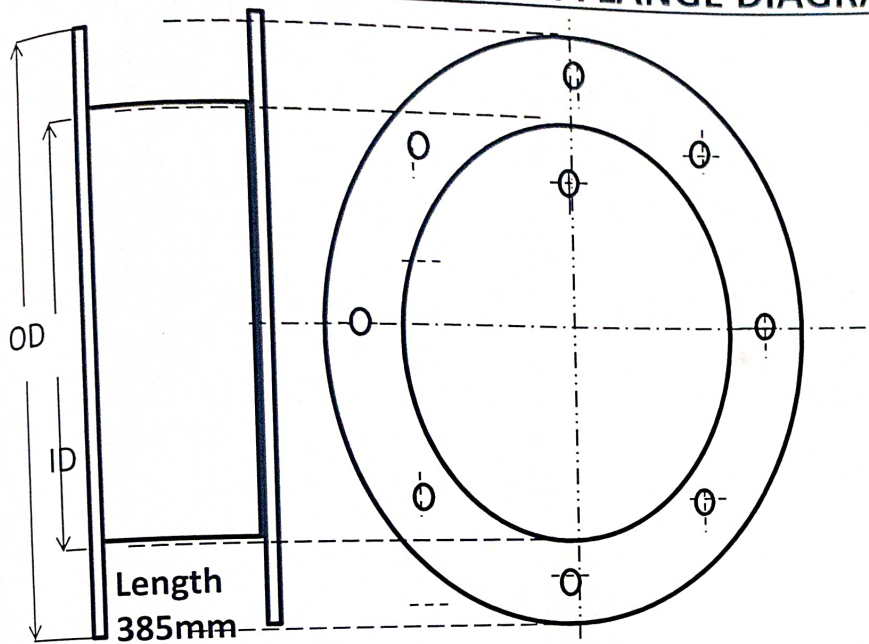

All dimensions are in mm

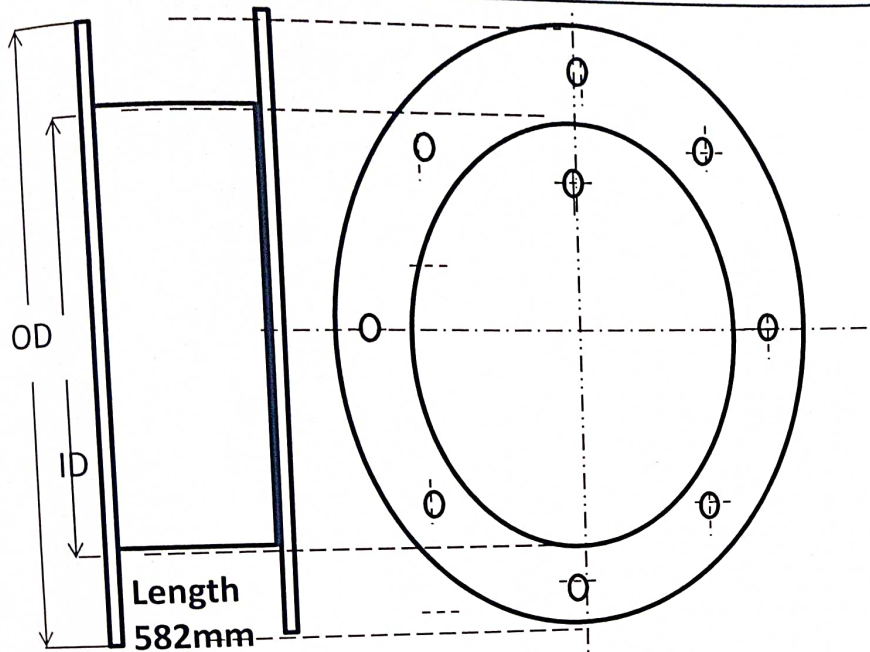
