Sub: Maintenance, Service and stamping by weights and measures department, Haryana Government, contract for one number of 30 MT Lorry Weighbridge at Jagadhri Rly siding.

We are having one number ATLAS make mechanical lorry weighbridge, converted in single load cell digital weigh bridge, at our Jagadhri Rly. Siding. The above subject contract will be for a period of two year and the same contract can be extended on the sole discretion of the management for further period of another one year on the following terms & conditions:

- 1 You are requested to quote service/maintenance charges per year for one number of 30 MT weighbridge **excluding GST**
- 2 The rates should be quoted in single bid format along with signed terms and conditions, for annual service/maintenance charges of one Nos. 30 MT weighbridge.
- 3 Eligibility criteria :
 - c) You must possess license from Weights & Measures Deptt, of Haryana Govt. to do maintenance work in the circle area. You have to submit valid license/ proof of applied for renewal of license.
 - d) Tenderer should submit copy of Pan Card and GST registration no.**
- 4 Necessary spare parts/labour will be provided by CCI to your service mechanic.
- 5 You will make quarterly visits (4 visits /year) for routine maintenance of weighbridge and in case of any sudden breakdown in our weighbridge you will have to send your mechanic immediately or within 36 hours after getting information from our end.
- 6 Corporation will not be responsible for any damage or injury to your mechanic/workmen during the maintenance of weighbridge.
- 7 50% payment will be made after satisfactory completion of two successive quarterly visits (i.e once in six months) after submission of bill.
- 8 You have to arrange stamping of weighbridge by weights and measures department, Haryana government, in time/before due date, which will be informed by CCI representative. Government fee for stamping charges will be paid by CCI.
- 9 In case of delay on your side penalty, if any, for the stamping of weighbridge will be paid by the contractor.

10 **As the contract value is small a nominal Security deposit of 5% will be deducted, of the value of the contract. Security deposit will be refunded within three months after successful completion of the contract.**
