## **Part-III : Special Terms and Conditions Manufacturing, Supply and Installation of 10 Ton Capacity Electric Winch Machine**

In addition to the General terms & conditions of the contract under Part-I & Part-II, the following special terms & conditions will also apply to the contract for Supply and Installation of 10 Ton Capacity Electric Winch Machine.

You are requested to quote your lowest rates for Supply and Installation of 10 Ton Capacity Electric Winch Machine with scope of work & terms and conditions as detailed below.

### **I. TECHNICAL SPECIFICATION OF EQUIPMENT**

As per Annexure-XI.

### **II. SCOPE OF WORK**

Manufacturing, supply and installation of 10 Ton Capacity Electric Winch Machine on FOR Bokajan basis.

#### **2.1 PARTY SCOPE**

- i) Manufacturing, supply and installation.
- ii) Freight of equipment on FOR Bokajan basis.
- iii) Supervise the installation of winch machine. Supervisor to and fro travel charges will be bear by contactor.
- iv) Warranty certificate of mechanical as well as electrical equipment from OEM. Party has to submit safe working load certificate with material from authorized testing firm.
- v) Arranging required manpower, to complete the job within time schedule.
- vi) Any other activities, not included above required for successful completion of the job shall be in the party's scope.

#### **2.2 CCI SCOPE**

- i) Electricity will be provided free of cost for execution of job.
- ii) Civil work based on GA drawing of electric winch machine submitted by party.

#### **3.0 ELIGIBILITY CRITERIA**

The tenderer should have experience in supply and installation of winch machine in industry. The supplied winch capacity must not lower than 05 Ton. For qualifying the eligibility criteria of techno commercial bid of the tender, the tenderer should provide the documents / copy of work order as a proof.

#### **4.0 ACCOMODATION**

Boarding, Lodging & Fooding will be in contractor scope, however in case if CCI Guest House is available , will be provided on chargeable basis. There are sufficient hotels available nearby locations & may be utilized for convenience of contractor on their own expenses.

**5.0 PRICE**

Price quoted in tender shall remain firm till the end of the contract period.

**6.0 EARNEST MONEY DEPOSIT (EMD)**

Nil

**7.0 SECURITY DEPOSIT(SD)**

If order value is more than 5.0 lakh, the security deposit an amount of 5% of contract value (i.e. including taxes, freight, P&F etc.), shall be deposited by successful bidders within 15 days from date of award of LOI/Work Order,.

The SD may be made either by bank draft or bank guarantee in favor of Cement Corporation Of India Ltd. from any nationalized bank in the prescribed form valid for a period of 6 months beyond the date of completion of contract with a further claim period of 3 months. The EMD will be adjusted towards portion of security deposit.

**8.0 GOODS & SERVICE TAX**

- i) The IGST/CGST/SGST, if applicable , will be paid on the cost of the finished goods being supplied , as per the rate (%) prevailing at the time of scheduled delivery period, subject to the supplier claiming the same as separate item on their bill.
- ii) The supplier shall furnish the following certificate on the body of the bill claiming aforesaid amount of IGST/CGST/SGST.
- iii) "It is certified that the goods, on which GST has been charged, have not been exempted under the GST or the rules made there under. The amount charged on account of GST on those goods are not more than what is payable under the provision of the relevant act or the rules made there under: "
- vi) GST will be paid subject to showing/appearing the same on GST portal under GSTR-2A report.

**9.0 PAYMENT TERMS**

1. Against supply of Material : 50 %
2. After successful installation of machine: 40%
3. Balance 10 % will be release after completion of warranty period.

In case the party does not submit Security Deposit , equal amount of security deposit will be deduct from bill. Amount of deducted security deposit will be release after submission of Bank Guarantee , equal amount of security deposit.

Payment will be release after statutory deductions as per Government Norms.

**11.0 DURATION OF CONTRACT**

Within 120 days from the days from the date of issue of work order. The party has to mobilize the workman within 30 days after receipt of material at our site for installation.

**12.0 TERMINATION OF CONTRACT**

CCI reserves the right to terminate/short close the contract within a month with 15 days prior notice to the party regarding reasons.

### **13.0 PAYING AUTHORITY**

### **14.0 PENALTY / L.D.**

In case of any failure on the part of the successful bidder for supply and installation of machine within the specified time, a penalty shall be imposed @ 0.5 % per fortnight subject a maximum 5% of contract value.

In the event of non-performance or poor performance of the work by the workman or any man made delay or damage due to negligence an amount equal to the cost to re-do the work to make it good will be charged as penalty and will be deducted from bill. No separate communication will be given to the contractor in this regard. Therefore, contractor has to deploy experience manpower to execute the job.

The completion of the job within the stipulated time is the essence of the contract and service must be performed within the time and subject to conditions specified. For any breach of contract, the corporation will be entitled to take any other course of action against the contractor as it may deem fit like debaring from tendering , stoppage of business dealing etc.

Further CCI reserves the right to cancel the order at risk and cost of the supplier, without any further reference to the successful bidder.

### **15.0 STATUTORY REQUIREMENT**

The tender should be accompanied by labour licence, ESIC, IT, PAN & GST reg. no. The contractor shall be responsible for fulfilling all the statutory requirements (related to this contract) as deemed necessary by different agencies. The contractor will bear all cost for above statutory requirement.

### **16.0 RULES AND REGULATION**

The contractor should follow strictly all the Rules and Regulations of the Corporation as well as the regulatory/statutory, Local Authority in connection with the contract. The contractor will be held responsible for any violation of the Rules and Regulations of the Corporation and regulatory/statutory authority.

### **17.0 ACCIDENT**

The contractor shall be liable for compensation to his labours payable under the Workman's Compensation Act, 1923 or any other Act in case of accident. In case he fails to pay the compensation, the Corporation reserves the right to make the payment and recover the same from any of his bills or Security Deposit. The contractor must obtain Licence from the Labour Licensing Authority before starting the work / fifteen days time of receiving LOI. Labour Licence and Insurance premium will be liability of the contractor. However, insurance premium will be reimbursed by the corporation. Photo copies of the above will be submitted to the P & A Department before the start of the work.

### **18.0 OTHERS TERMS & CONDITION**

- a) The validity of the rates quoted shall be for 120 days from the date of opening of tender.
- b) All tools & tackles/measuring instruments required for executing jobs are the responsibility of tenderer.
- c) The successful tenderer must submit the ID proof, Any accidental policy cover, PPE If any,

Aadhar card each of their employee who is attending the job inside the factory.

- d) The employee who is attending the job must cover under accidental policy/ESIC.
- e) The employee who is attending the job must use PPE during visit.

The persons engaged by the contractor for taking up the jobs should not be under the influence of liquor or any other drugs while working. In case anybody is found in drunken condition, such person shall not be allowed to work.

The contractor will follow all the Rules & Regulations of labour Laws as enforced by the State/Central Government from time to time.

All Safety rules & regulations should be followed strictly. The safety of persons deployed by the contractor shall be the responsibility of the contractor. It is advisable to him to issue all required PPEs to their employees as on when required & insist to him to bear the same during the working hours. In case of any accident/injury to the persons engaged by the contractor, CCI will not be liable to pay anything in this regard.

CCI will provide only required machines such as Welding machine etc. which are not related to testing directly but will not provide any technical staff regarding the testing.

## **19.0 GUARANTEE**

The bidder shall stand guarantee for the work done for trouble free operation for a period of 06 (Six) Months from the date of commissioning. Any damage or defect or other faults that may arise or lie undiscovered at the time of issue of completion certificate, or appear within the defect liability period after virtual completion of the work, occurring in the opinion of the owner, due to material or workmanship not being in accordance with the contract, shall, upon the direction of the owner in writing and within such reasonable period specified therein, be rectified by the contractor most expeditiously at his own cost, or in case of default, CCI may get the same rectified/ made good by other workman and deduct expense from any sums that may be there or at any time thereafter that become due to the contractor or may recover from his security deposit. CCI shall be under no obligation to accept/ entertain any claim/ demand whatsoever on this behalf. The workmanship guarantee for rectified portion of work shall commence with effect from the date of rectification for a subsequent period of 06 (six) months of the balance period as stated above, whichever is later.
