Part-III: Special Terms & Condition for procurement of Design, Supply, Erection & commissioning of Weigh Feeder (Belt Type) for Clinker Feeding in Cement Mill.

In addition to the General terms & conditions of the tender Part-I & Part-II, the following special terms & conditions will also apply to the contract for Design, Engineering, and Manufacturing & Supply of Belt type Weigh feeder for clinker feeding in Cement Mill.

### I) <u>Eligibility Criteria</u>:

- (a) The parties who are in the field of manufacturing & supply of cement plant machinery are eligible subject to Manufacturing of Belt type Weigh feeder at their own workshop or at their authorized workshop. In case these are to be manufactured at their authorized workshop, they shall submit the following testimonials:
  - i. The consent letter from the authorized workshop confirming to be the party's authorized workshop for manufacturing of such items.
- ii. The authorized workshop should have manufactured Belt type Weigh feeder in the past. Documentary evidence shall be submitted to that effect.

Or

(b) The parties who are the suppliers of Entire Cement Plant Machineries are also eligible.

The tenderer should furnish documentary evidence like Purchase / Work order and in support of their experience for manufacturing & supply of Belt type Weigh feeder and submit copies of orders executed with complete specifications. Parties also have to submit the Customer satisfactory certificate of supplied Weigh feeder from their clients.

#### II) Warranty / Guarantee:

- 1. The party shall give performance guarantee for a period of 12 months from the date of commissioning. During the period of 12 months the party should do free replacement of any internals, or rectify any defects arising during the period.

100% payment towards cost of material excluding GST and including freight shall be released by the concerned unit within 30 days after receipt, physical inspection, Erection & commissioning at factory site & after adjustment of any recovery/ liquidated damages for delay in delivery, if any. GST will be reimbursed on the basis of GSTR-20 repot.

#### VIII) <u>SECURITY DEPOSIT</u>: -

- 1. You shall have to furnish a security deposit equivalent to 5% (five percent) value of the order calculated on landed cost basis i.e. basic price plus GST and freight by way of demand draft/bank guarantee from any nationalized bank (in CCI's format to be provided by respective unit) in terms of clause 2 of Part II of the tender documents towards satisfactory performance. Security deposit is to be submitted within 7 days from the date of this Letter of Intent / P.O.
- 2. This security Deposit shall be refunded within 3 months from the date of satisfactory completion warranty period.
