Failure to furnish security deposit in accordance of offer/issue of Work order will be considered to be breach of contract which would give the Corporation the right to terminate the contract and forfeit the contract.
- 6. The Security Amount shall be forfeited if the tenderer withdraw his tender during the validity period of the tender.
- 7. The bid shall remain valid for a period of three months from the date of opening of the tender.
- 8. The rates quoted shall remain unchanged during the currency or extended period of the contract and no increase what so ever shall be allowed.
- 9. CCI reserves the right to accept/reject any bid to cancel the biding process at any time and reject all bids, at any stage prior to placement of order, without thereby incurring any liability.

10. Dispute Under this contract and Arbitration:-

10.1 In the event of any question/dispute breach of or difference arising in respect of the meaning and scope of terms & conditions herein or in connection with any matter under this agreement (except for those matters which are to be decided as per provisions

made in these terms & conditions) the same shall be referred to GM of CCI Ltd. Rajban For appointment of a sole Arbitrator. There will be no objection if the Arbitrator so appointed is or was an Employee of the corporation and whether he had at any time in discharge of his duties as an Employee had expressed views on all or any of the matter in dispute or difference or dealt with matter in substance. The Arbitrator shall give award with reasons in respect of each claim, dispute or difference referred to him in the event the value of the dispute(s) exceeds Rs.50,000/-. The award of the Arbitrator shall be final and binding on the parties to this Contract.

- 10.2 Subject to aforesaid the Arbitration and Conciliation Act, 1996 the rule made there under any statutory modifications thereof for the time being in force shall apply to the arbitration proceedings under this clause.
- 10.3 The work under this contract shall be continued uninterrupted during the pendency of the Arbitration Proceedings and no payment due from one to the other parties therein shall be withheld on account of pendency of such Proceeding unless such payment related to the matters under Arbitration.
- 10.4 The venue of the Arbitration shall be Rajban or such other place as the Arbitral Tribunal at his discretion made determined.
- 10.5 All matter connected with this shall be governed by the Indian Law both substantive and procedural, for the time being in force and shall be subject to the jurisdiction of Indian Courts at Paonta Sahib (HP).

### PART-III (SPECIAL TERMS AND CONDITIONS)

- 1. The License will be given for two years (2), which can be extended further for another one (1) year (2+1), subject to satisfactory performance of the licensee, be mutual consent in writing.
- 2. H-1 Bidder will be provided shop and accommodation in CCI colony. The monthly license fees plus applicable taxes extra both for shop & residence will be charged and bill will be raised in the starting of the month. The license fee of each month will have to be deposited by 15th of subsequent month after that Rs. 20 per day penalty will be imposed.
- 3. The electricity charges will be on actual basis of meter reading on commercial rates. The electricity charges are to be paid by the licensee within 10 days from the date of receipt of the bill failing which an additional 10% surcharge will be levied and in case of default for the consecutive months, the supply will be disconnected.
- 4. The minimum monthly license fee for bid is starting from Rs. 3000/- (Rupees Three Thousand only) as applicable both for shop & residence plus applicable taxes extra.
- 5. The license shall not in any way assign rights or carry out any business other than for which the license is granted or employ or take the assistance of any one whose names are not approved by the company. Further no subletting will be allowed and you shall run the shop yourself and in case anyone other than you found running the shop, the license will be terminated forthwith without any notice.
- 6. You will be keep sufficient quantity of items for which you been granted this license.
- 7. The shops are being allotted/licensed 'as is where is' basis.

- 8. No structural alteration of any type shall be made without written permission of CCI.
- 9. The business hours shall be fixed as per the convenience of the employee's/colony residents. CCI may at any time impose change in business hours to suit the needs of the employee's/colony residents. The license shall not close the stall/shop or suspend his business without valid reasons and without prior intimation to the company.
- 10. CCI will not be responsible for any transactions carried on between the license and customers.

- 11. CCI will not be responsible for the protection of the property of the licensee.
- Damage of disfiguration of any nature to the premised and fixtures shall be subject to compensation at replacement cost.
- 13. The premises are subject to inspection at any time without notice by the person duly authorized by the management.
- 14. Area provided of commercial shop is 250 sqft. in a 25 x 10 feet.
- 15. Tenderers shall visit place/shop before submission of Tender.
- 16. You will charge the rates for items on Attractive/ Appropriate discounts than the rates prevalent in the Paonta Sahib market. You will also display the rates of available items at the shop.
- 17. The license is terminable with two months' notice by the licensee or on payment of two months' license fee in lieu of the notice period.
- 18. CCI reserves the right to terminate the license by one month's notice without assigning any reason or without any notice on infringement of the terms of the license on the license on the date of expiry of the notice period, the licensee shall remove his goods and vacate the stall/shop peacefully and on his failure to do so, CCI will report for incident to Local Administration (Police Department) to appropriate action.
- 19. Bio-Waste Management will be in a proper way. The premises and surroundings of the shop shall be kept clean and tidy by keeping big covered waste bins at appropriate places and are subject to inspection by the officials of CCI.
- 20. The licensee has to pay amounts, in case of any accident to the personnel employed by them during the business time. The licensee alone is liable for workmen's compensation and any other statutory dues. CCI is not liable for payment of any such compensation.
- 21. No child labour shall be employed for servicing as per law.
- 22. In case of dispute arising out of the terms and conditions of this contract, the decision of CCI shall be final and binding on the licensee.
- 23. CCI reserves the right to impose any other conditions on the licenses and when necessary in the interest of the company.
- 24. The tenderer will require a valid license to run shop from Licensing Authorities.
- 25. Supplied Fast Food/items should be fresh and made of good quality products. If CCI received any complaint/issues related to adulterated, unsafe and substandard food products or any health issue then licensee shall be responsible.
- 26. The tenderer should open the shop and shall remain open every day including Sunday. However tenderer should be available in case of emergency during odd times.

- 27. There is no transfer of interest of the shop to the licensee under this license but only a right to licensee to run the shop.
- 28. The payment of any bill against goods supplied or services rendered to the Corporation should note linked with the payment of rent and other charges.
- 29.In case licensee is interested to continue to run the shop, he should submit his intention in writing before one month of completion of the license period.
