SPECIAL TERMS AND CONDITIONS FOR PLANT RETURN WATER PIPE LINE LAYING WORK SHIFT OFFICE TO CEMENT MILL AT CCI TANDUR.

In addition to the General Terms and Conditions of tender under PART– I& II, the following terms and conditions will also apply to the contract. These special terms and conditions, if contradictory to any conditions given in PART – I & II, will prevail upon the conditions given therein in PART III. Also, in case of doubt regarding description of work, its meaning, the interpretation of CCI will be final.

This tender contains special terms and conditions and price bid. All these documents are to be submitted duly signed and stamped by the tenderer.

- 01) Contractor is deemed to be aware of the site conditions before quoting the rates.
- 02) **SCOPE OF WORK** :-Excavation for laying of C.I pipes 300mm dia. Shifting of C.I. pipes 300mm dia& fittings and Misc., items required for the work etc., from plant stores to site of work etc., including, transportation by truck or tractor and trailer. Chamber masonry work as directed by Engineer-in-charge.
- 03) Laying & Fixing and jointing of C.I. pipes 300mm dia&fittings from chamber to chamber main line of pump house and as directed by Engineer-in-charge.
- 04) **Soil investigation report of CCI Plant:** Safe load bearing capacity of Black Cotton soil is 5.0 Tonne / M². However, the foundation may be designed based on assumption that it will rest on Rock/Limestone of safe bearing capacity of 40.0 Tonne / M².
- 05) **Level of Soil:** CCI Tandur plant is covered by Black Cotton soil layer of about 1 (One) Metre average thickness over hard rock (Limestone strata).
- 06) Cement, C.I. pipes 300mm dia& fittings will be issued free of cost from CCI store/Packing plant and all other building material like Bricks, Tor steel, Coarse aggregate, Sand, Centering and Shuttering materials etc will be arranged by the party. All the civil construction material except cement, C.I. pipes 300mm dia& fittings will be at the cost of party. Cement will be issued as per the design mix/nominal mix, as per the CPWD consumption pattern. Cement consumption is allowed as per the CPWD / DSR-2018 Permissible variation limit for cement consumption is (+/-) 3% consumption of cement as per CPWD norms (Cement will be issued at free of cost basis for excavation of the work). Excess consumption over +3% will attract penal recovery at market value +10% as overheads.
- 07) The materials required for the work shall be issued to the contractor at free of cost. The contractor shall have to maintain complete account of the materials & spares issued to him. Worn out as well as spares fittings etc., shall be returned to the corporation. The safe custody of the materials issued entirely lies with the contractor. In case of loss /damage or non return of materials recovery shall be made from the contractor at the rate of items book value + 10%.
- 08) The contractor must obtain labour license from the labour licensing authority.
- 09) The contractor shall follow all orders, rules and regulation of CCI.
- 10) The contractor has to adopt all measures for providing safety equipments for safe working of his employees.
- 11) Contractor shall provide all safety items (PPE) as per requirement and all the contract labour should be follow the safety rules according to Corporation.
- 12) Contractor shall obtain Medical Fitness Certificate as per Factories Act 1948 & Rules 1950 before deploying into work of his workman.
- 13) The Contractor shall verify antecedents of his workmen engaged by him and ensure that the workmen engaged by him carry with them proper identity cards bearing their photographs to be issued by him and carry during the working hours.

- 14) The contractor must pay Minimum Wages to his workmen fixed by the Government of Telangana from time to time. The Contractor is required to adhere to the provision / requirements under the Contract Labour (R.A.) Act, Minimum wages Act and or any other statutes as may be made applicable from time to time. Insurance coverage for the workmen from any accident should also be ensured in respect of the workmen engaged by him. All the labours working for this should be covered by workmen compensation insurance policy.
- 15) The Contractor undertakes that it has complied with and agrees to comply with all the necessary statutory requirements such as maintaining Registers, Records and Returns under Contract Labour (Regulation & Abolition) Act, 1970, Factories Act, 1948, Minimum Wages Act, 1948, Payment of Wages Act 1936, Payment of Bonus Act, 1965, Employees' Provident Funds & Miscellaneous Provisions Act, 1952, Employees' State Insurance Act, 1948, Employees' Compensation Act, 1923, Labour Welfare Fund Act, 1987, The Industrial Employment (Standing Orders) Act, 1946.etc. as applicable to its business for providing the said services.
- 16) The Contractor shall also comply with the provisions of the Act and such other statutory enactments, rules and regulations laid down by the Government or local body whether related to labour, commercial or other laws in force or coming into force which may apply to this Agreement or Contract and any liability on account of non-compliance or violations thereof by it, shall be solely to the account of the Contractor and the Company shall not be responsible for any breach or violation by the Contractor. The Contractor hereby agrees to indemnify and keep indemnified the Company against any claim, loss, damage, cost, charge or expense incurred or suffered by the Company on account of any breach or violation of the necessary statutory requirements by the Contractor.
- 17) The contractor shall ensure that the workmen engaged by him are medically fit and no worker should be engaged who is below the age of 18 years or has attained the age of 58 years.
- 18) The contractor has to make gate entry of each item wise materials taken by him for each trip through CCI on returnable gate pass signed by him and taking counter signature of the concerned official. The contractor has to make entry at main gate for each and every trip for taking materials inside and bringing inside the plant whenever required for the work. The contractor is fully responsible for safety of materials issued by CCI like C.I. pipes & fittings etc.,
- 19) The contractor's quoted rate should be deemed to be inclusive of labour rate, tools and tackles and all processes required for completion of work.
- 20) In case of non satisfactory performance from contractor, corporation reserves right to terminate the work or execute the work through other agencies at the risk and cost of the contractor.
- 21) While working at site proper care should be taken to avoid accidents and incase of accident occur all the expenditure should be borne by the contractor and CCI is not responsible for the same.
- 22) The contractor should provide necessary tools & tackles to his workmen. All tools and tackles for the work as required shall be arranged by the contractor at his own cost. Electrician required for giving connections to motors and any other electrical related works are in free of the CCI scope.
- 23) Contractor should submit the details of his manpower to CCI civil dept., prior to engaging him on the job. In case of absenteeism of any of the manpower, alternate arrangement of suitable manpower may be engaged immediately and operation of water supply to plant should not be affected.
- 24) **ELIGIBILITY CRITERIA:** They should have a experience in Civil construction field / earth excavation / pipe line work or any other Civil related works for a minimum period of one year.
- 25) **PENALTY/LD:** The work to be completed within (02) two months from the date LOI / work order issued. If not completed within the stipulated time will attract penalty at Rs.500/- perday.

- 26) **PERIOD OF CONTRACT:-** The period of contract is (2) two months from the date of issue of LOI or Work order. Contract period can be extended (or) reduced further up to completion of work whichever is earlier, with the same rates, terms & conditions by CCI if required.
- 27) **QUANTITY:-** Quantity may vary \pm 25% for the individual items and overall variation shall be \pm 25% over the estimated quantity.
- 28) **PAYMENT:-**Payment will be made as per actual measurement on work done basis on submission of bill from the contractor within (15) days. Which will be recorded in MB.
- 29) **GST:** Contractor should register themselves under GST and provide GST Registration number. Eligible GST will be paid by CCI to the contractor and after submission of proof of payment by the Contractor, towards GST, the same will be adjusted in GST account. Therefore contractor should ensure payment of GST within the time given by the Government. If GST is mentioned as '0' or not mentioned in the price bid it will be treated as inclusive and L-1 shall be arrived for comparison by the debiting the input credit from the quoted rates.
- 30) **SECURITY DEPOSIT (S.D.) :**
Successful tenderers should furnish Security Deposit 5% of total order / contract value, within 15 days from the date of issue of LOI / WO, Security Deposit shall be obtained by way of **DD/BG /RTGS to A/c No. 62017406489, IFSCBIN000446**. The Security Deposit will be refunded after 03 (THREE) months of the successful completion of the contract period and on submission of No claim certificate from the party.
- 31) **Income Tax & GST:**
- 1) Payment terms:-100% payment will be made after deduction of applicable taxes & recoveries within 15 days from submission of bills duly certified by HOD (Civil) routed through HOD (P&A) to HOD (Fin) for payment by way of RTGS / NEFT.
 - 2) The GST tax amount will be reimbursed to the contractor after the same was paid to the government account by him and upload their respected invoices in their GST portal in the succeeding month and submit proof for the same for reimbursement.
 - 3) TDS on GST Act 2% and TDS on income tax act will be made as per rule in force.
- 32) **DISPUTE UNDER THIS CONTRACT AND ARBITRATION:**
- 32.1) In the event of any question/dispute, breach of or difference arising in respect of the meaning and scope of terms and conditions herein or in connection with any matter under this agreement (except for those matter which are to be decided as per provisions made in these terms and conditions) the same shall be referred to the sole arbitration by an officer of the Cement Corporation of India Limited, New Delhi appointed by its C& MD. There will be no objection if the arbitrator is an employee of the Corporation and he had at anytime in discharge of his duties as an employee of the Corporation has expressed views on all or any of the matters in dispute or difference. In case the employee of the Corporation who has been so appointed as an Arbitrator ceases to be in the employment of the Corporation because of his superannuation or otherwise in any manner, shall no longer remain as an Arbitrator from that day and C&MD of the Corporation shall appoint another employee of the Corporation as sole arbitrator in his place who shall proceed in the matters from the stage where the previous arbitrator had left the proceedings. Except where the award is an arbitral award on agreement terms under section 30 of the Arbitration and Conciliation Ordinance, 1996, the arbitrator shall give award with reasons in respect of each claim, dispute or a difference referred to him. The award of the arbitrator shall be final and okay and binding on the parties to this contract and persons claiming under them respectively.
- 32.2) Subject to aforesaid the Arbitration and Conciliation Ordinance, 1996 and the rules made there under and any statutory modifications thereof for the time being in force shall apply to the arbitration proceedings under this clause.
- 32.3) The work under the contract shall be continued uninterrupted during the pendency of the arbitration proceedings and no payment due from one to the other parties therein shall be with held on account of pendency of such proceedings unless such payment related to the matter under arbitration.
- 32.4) The venue of the arbitration shall be New Delhi or such other place as the arbitral tribunal at his discretion may determine.
