3. Purchase preference will be given to MSEs having valid Udyam Registration and whose credentials are validated online through Udyam Registration portal as defined in Public Procurement Policy for Micro and Small Enterprises (MSEs) Order, 2012 dated 23.03.2012 issued by Ministry of Micro, Small and Medium Enterprises and its subsequent Orders/Notifications issued by concerned Ministry. If the bidder wants to avail themselves of the Purchase preference, the bidder must be the manufacturer / OEM of the offered product on GeM. Traders are excluded from the purview of Public Procurement Policy for Micro and Small Enterprises and hence resellers offering products manufactured by some other OEM are not eligible for any purchase preference. In respect of bid for Services, the bidder must be the Service provider of the offered Service. Relevant documentary evidence in this regard shall be uploaded along with the bid in respect of the offered product or service and Buyer will decide eligibility for purchase preference based on documentary evidence submitted, while evaluating the bid. If L-1 is not an MSE and MSE Seller (s) has / have quoted price within L-1+ 15% (Selected by Buyer) of margin of purchase preference /price band defined in relevant policy, such MSE Seller shall be given opportunity to match L-1 price and contract will be awarded for 25% (selected by Buyer) percentage of total quantity. ### INTEGRITY PACT

### Between Cement Corporation of India Limited (CCI) hereinafter referre d to as "The Principal", and ------herein after referred to as "The Bidder/Contractor"

### **Preamble:**

The Principal intends to award, under laid down organizational procedures, contr act/s for ------The Principal value full compliance with all relevant law s of the land, rules, regulations, economic use of resources and of fairness / tran sparency in its relations with its Bidder(s) and / or Contractor(s). In order to achi eve these goals, the Principal will appoint an Independent External Monitor (IEM) , who will monitor the tender process and the execution of the contract for comp liance with the principles mentioned above. Section 1 - Commitments of the Prin cipal

1) The Principal commits itself to take all measures necessary to prevent corrupt ion and to observe the following principles:-

a) No employee of the Principal, personally or through family members, will in co nnection with the tender for, or the execution of a contract, demand, take a p romise for or accept, for self or third person, any material or immaterial bene fit which the person is not legally entitled to.

- b) The Principal will, during the tender process treat all Bidder(s) with equity an d reason, The Principal will in particular, before and during the tender proces s, provide to all Bidder(s) the same information and will not provide to any Bi dder(s) confidential additional information through which the Bidder(s) could obtain an advantage in relation to the tender process or the contract executi on.
- c) The Principal will exclude from the process all known prejudiced persons. (2) I f the Principal obtains information on the conduct of any of its employees whi ch is a criminal offence under the IPC/PC Act, or if there be a substantive suspicion in this regard, the Principal will inform the Chief Vigilance Officer an d in addition can initiate disciplinary actions.

### Section 2 - Commitments of the Bidder(s)/ contractor(s) :

The Bidder(s)/ Contractor(s) commit himself to take all measures necessary to p revent corruption. He commits himself to observe the following principles during his participation in the tender process and during the contract execution.

- a) The Bidder(s)/Contractor(s) will not, directly or through any other person or fir m, offer, promise or give to any of the Principal's employees involved in the te nder process or the execution of the contract or to any third person any mater ial or other benefit which he/she is not legally entitled to, in order to obtain in exchange any advantage of any kind whatsoever during the tender process or during the execution of the contract.
- b) The Bidder(s)/Contractor(s) will not enter with other Bidders into any undisclo sed agreement or understanding, whether formal or informal. This applies in p articular to prices, specifications, certifications, subsidiary contracts, submissi on or non-submission of bids or any other actions to restrict competitiveness o r to introduce cartelization in the bidding process.
- c) The Bidder(s)/Contractor(s) will not commit any offence under the relevant IP C/PC Act; further the Bidder(s)/ Contractor(s) will not use improperly; for purpo se s of competition or personal gain, or pass on to others, any information or d ocument provided by the Principal as part of the business relationship, regard ing plans, technical proposals and business details, including information cont ained or transmitted electronically.
- d) The Bidder(s)/Contractor(s) of foreign origin shall disclose the name and addr ess of the Agents/representatives in India, if any. Similarly the Bidder(s)/Contr actor(s) of Indian Nationality shall furnish the name and address of the foreign principals, if any, Further details as mentioned in the "Guidelines on Indian Ag ents of Foreign Suppliers' shall be disclosed by the bidder(s) / Contractor(s). F urther, as mentioned in the Guidelines all the payments made to the Indian ag ent/representative have to be in 'Indian Rupees only.
- e)The Bidder(s)/Contractor(s) will, when presenting his bid, disclose any and all payments he has made, is committed to or intends to make to agents, broker s or any other intermediaries in connection with the award of the contract
- f) The Bidder(s)/Contractor(s) will not instigate third persons to commit offences

outlined above or be an accessory to such offences.

- g) Bidder(s)/Contractor(s) signing IP shall not approach the court while represent ing the matters to IEMs and he/she will await their decision in the matter.
- h) In case of a joint venture, all the partners of the joint ventures to signed the IP
- i) Any violation of Integrity Pact would entail disqualification of the Bidders and exclusion from future business dealings, as per the existing Provision of GFR, 2017, PC act, 1988 and other Financial Rules/Guidelines etc. as may be applic able to the origination concerned.
- j) In the event of any dispute between the management and the contractor relating to those contracts where integrity pact is applicable, in case, both the parties are agreeable, they may try to settle dispute through mediation before the panel of IEMs in a time bound manner. If required the Organizations may adop t any mediation rule for this purpose. In case, the dispute remains unresolved even after mediation by the panel Of IEMs, the organizations may take further action as per the terms & Conditions of the contract.

**Section 3**-Disqualification from tender process and exclusion from future contra cts:

- (1) If the Bidders(s)/Contractor(s), before award or during execution has commit ted a transgression through a violation of Section 2, above or in any other for m such as to put his reliability or credibility in question, the principal is entitl ed to disqualify the Bidder(s)/Contractor(s) from the tender process or to ter minate the contract, if already signed for such reason.
- (2) If the Bidder/Contractor has committed a serious transgression through a violation of sector-2 such as to put his reliability or credibility into question, the principal is entitled also to exclude the Bidder/Contractor from future contract award processes. The imposition and duration of the exclusion will be deter mined by the severity of the transgression. The severity will be determined by the circumstances of the case, in particular the number of transgressions, the position of the transgressors with the company hierarchy of the Bidder and the amount of the damage. The exclusion will be imposed for a minimum of 6 months and maximum of 3 years.
- (3) If the Bidder/Contractor can prove that he has restored/recouped the damag e caused by him and has installed a suitable corruption prevention system, t he Principal may revoke the exclusion prematurely.
- (4) A transgression is considered to have occurred if in light of available eviden ce no reasonable doubt is possible.

Section 4 - Compensation for Damages :

- (1) If the Principal has disqualified the Bidder(s) from the tender process prior to the award according to Section 3, the Principal is entitled to demand and rec over the damages equivalent to Earnest Money Deposit/ Bid Security.
- (2) If the Principal has terminated the contract according to Section 3, or if the P rincipal MM entitled to terminate the contract according to Section 3, the Prin cipal shall be entitled to demand and recover from the Contractor liquidated damages of the Contract value or the amount equivalent to Performance Ban k Guarantee.

### Section 5 - Previous transgression:

- (1) The Bidder declares that no previous transgressions occurred in the last 3 ye ars with any other Company in any country conforming to the anti-corruption approach or with any other Public Sector Enterprise in India that could justify his exclusion from the tender process.
- (2) If the Bidder makes incorrect statement on this subject, he can be disqualifie d from the tender process.

### Section 6- Equal treatment of all Bidders/Contractors/Sub-contractors :

- (1) The Bidder(s)/ Contractor(s) undertake(s) to demand from all subcontractors the commitment consistent with this Integrity Pact, and to submit it to the Pri ncipal before contract signing.
- (2) The Principal will enter into agreements with identical conditions as this one with all Bidders and Contractors.
- (3) The Principal will disqualify from the tender process all bidders who do not si gn this Pact or violate its provisions.

# Section-7- Criminal charges against violating bidder(s)/Contactor(s)/Su bcontractors:

If the Principal obtains knowledge of conduct of a Bidder, Contractor or Subcont ractor, or of an employee or a representative or an associate of a Bidder, Contra ctor or Subcontractor which constitutes corruption, or if the Principal has substa ntive suspicion in this regard, the Principal will inform the same to the Chief Vigil ance Officer.

### Section 8 -Independent External Monitor/Monitors :

- (1) The Principal appoints competent and credible Independent External Moni tor for this Pact. The task of the Monitor is to review independently and obj ectively, whether and to what extent the parties comply with the obligatio ns under this agreement.
- (2) The Monitor is not subject to instructions by the representatives of the pa rties and performs his functions neutrally and independently. He reports t o the Chairman, CCI.

(3) The Bidder(s)/Contractor(s) accepts that the Monitor has the right to acce ss without restriction to all tender documentation of the Principal including that provided by the Contractor. The Contractor will also grant the Monitor , upon his request and demonstration of a valid interest, unrestricted and unconditional access to his project documentation. The same is applicable to Subcontractors. The Monitor is under contractual obligation to treat the information and documents of the

Bidder(s)/Contractor(s)/Subcontractor(s) with confidentiality.

- (4) As soon as the Monitor notices, or believes to notice, a violation of this ag reement, he will so inform the Management of the Principal and request th e Management to discontinue or take corrective action, or to take other rel evant action. The monitor can in this regard submit nonbinding recommen dations. Beyond this, the Monitor has no right to demand from the parties that they act in a specific manner, refrain from action or tolerate action. H owever, the independent External Monitor shall give an opportunity to the Bidder/Contractor to present its case before making its recommendations to the Principal.
- (5) The Monitor will submit a written report to the Chairman, CCI within 5 to 1 0 weeks from the date of reference or intimation to him by the Principal an d, should the occasion arise, submit proposals for correcting problematic situations.
- (6) Monitor shall be entitled to compensation on the same terms as being ext ended to / provided to Independent Directors on the CCI Board.
- (7) If the Monitor has reported to the Chairman CCI, a substantiated suspicion of an offence under relevant IPC/PC Act, and the Chairman, CCI has not, wi thin the reasonable time taken visible action to proceed against such offen ce or reported it to the Chief Vigilance Officer, the Monitor may also trans mit this information directly to the Central Vigilance Commissioner.
- (8) The word 'Monitor/ would include both singular and plural.
- (9) Independent External Monitor shall be required to maintain confidentially of the information acquired and gathered during their tenure/role as indep endent Monitor. Any breach in this regard would be subject to the legal judicial system of India.
- (10) Independent External Monitor(s) shall be required to furnish an Undertaki ng and disclose before taking any assignment that he/she has no interest i

n the matter or connected with the party (Bidder/Contractor) in any mann er.

### Section 9 — Pact duration :

This pact begins when both parties have legally signed it. It expires for the Contr actor 12 months after the last payment under the contract and for all other bidd ers 6 months after the contract has been awarded. If any claim is made/lodged d uring this time, the same shall be binding and continue to be valid despite the la pse of this pact as specified above, unless it is discharged/determined by Chair man of CCI.

### Section 10 — Other provisions:

# PART - III : SPECIAL TERMS & CONDITIO

# E-Tender for the contract for supply & transportation 5000MT±25% of dry Fly ash from any other source except HPGCL Yamunanagar to Raj ban Cement Factory by Road.

In addition to the general terms and conditions of the tender viz part I, II, and III the following special ter ms and conditions will also apply to the contract. The terms & conditions if contradictory to any one give n in part I, II & III the special terms and conditions shall prevail upon such conditions.

# 1.0 SCOPE OF WORK:-

- 1.1 The contractor shall undertake the supply of dry fly ash as per instruction s given by the concerned authority of Rajban Cement Factory and is to be taken up immediately.
- 1.2 Arrangement of material (Dry fly ash), loading in suitable vehicles, trans portation up to CCI Rajban will be in the scope of successful tenderer and unloading inside the factory at proper place will be in the scope of CCI, R ajban.
- 1.3 The supplier shall provide bulker as per delivery schedule/ instructions b y production department for 5000MT±25% Dry Fly Ash.
- 1.4 CCI Rajban Cement Factory which is situated at a distance of 10KM from Paonta Sahib, Distt. Sirmour (H.P.) and Paonta Sahib is situated 71KM from Yamunanagar.
- 1.5 No transshipment shall be done en-route, except in case of any break do wn for which transporter has to take specific permission from CCI authorit ies.
- 1.6 Any damage claim due to the supplier/contractor or his vehicle will be lia bility of supplier.
- 1.7 Rate /MT includes Cost of dry fly ash, loading and transportation and en -route expenses .

# 2.0 <u>QUANTITY:</u>-

- 2.1 The quantity of fly ash to be supplied is 5000 MT±25% Dry Fly Ash fro m HPGCL Yamunanagar.
- 2.2 The quantity given is only indicative may vary  $\pm 25\%$ . The contractor sh all not be entitled to have any claim or compensation whatsoever on this account.

2.3 The corporation reserves the right to transport the fly ash in the truck/ta nker/ containers owned/hired by CCI, if deemed necessary or to arrange other means of transport in case of urgency at its discretion. The corporation reserves its right to carry the supply through other agency /contractor on the risk and cos t of the supplier.

### 3.0 <u>QUALITY:-</u>

- a) Material should be as per IS: 3812 part-I
- b) Moisture maximum 2%, if the moisture found more than specified pa yment will be deducted on prorate basis on landed cost of material.

# 4.0 <u>RATES :-</u>

4.1 The rates should be quoted on per MT basis after considering the scope given under clause no.1.0 (scope of work) and inclusive of all taxe s, duties and other levies such as toll taxes etc. applicable en-route up t o Rajban cement factory except GST on the transportation of material. H owever the AGT levied by H.P. Govt. will be reimbursed by the corporatio n after verifying the same.

4.2 The rates should be quoted for above scope of work (clause -1) of the part-III Special terms and conditions for the supply of dry fly ash fro m any other source (except HPGCL Yamunanagar) to Rajban cement Fac tory on per MT basis.

4.3 No detention or statistical charges shall be paid by the corporatio n.

4.4 The rates quoted shall remain firm for a period of one year & also for the extended period of contract, if any during the contract period.

4.5 In the event of negotiation only downward revision of rates will be allow ed any change in techno commercial terms are agreed earlier will not be permi tted at this stage. Any qualifying remarks in the price bid, revised/negotiated of fer will not be entertained.

- 4.6 No escalation/de-escalation shall be admissible in any case whatsoever, ex cept in the event of price variation of diesel. In case of variation of diesel price, for every 10 paisa per liter variation, from the last date of submissi on of tender, 0.33 paisa per km / MT shall be varied in rate as per followin g formula [0.33 paisa per km per MT\* distance in KM\*variation in d iesel rate (₹/ltr) /10paisa/ltr]. The distance will be taken 71 Km only o ne-way for this purpose.
- 4.7 The approx. quantity of dry fly ash to be supplied is **5000 MT±25%.** Ho wever, the corporation reserves the right to divide the quantities between L-1, and L-2 tenderers in the ratio of 70:30, if L-2 tenderer match the L-1 r ates. In case L-2 tenderers do not match the L-1 rates, option will be give n to other tenderers starting from L-3,L-4...., to match L-1 rates and accor dingly quantities will be divided in the ratio of 70:30 between L-1 tenderer r and the tenderer who match the L-1 rates. If L-2/L-3/L-4.... tenderer do not match the L-1 rates, full quantity will be awarded to L-1 tenderer.

# 5.0 <u>WEIGHMENT</u> :-

Lowest of the two weight recorded (source and Rajban) will be

taken for the payment purpose.

# 6.0 <u>PENALTY</u>:-

- 6.1 The supplier is required to place sufficient no. of bulkers for supply of dry fly a sh as per the delivery schedule / instructions from Rajban Production departme nt.
- LD will be imposed for short supply @ 0.5% per fortnight subject to maximum
   5% value of the contract.

# 7.0 TAXES & DUTIES:-

The contractors shall be responsible to obtained toll tax exemption at transit points for which ne cessary declaration shall be furnished by CCI or its authorized agent. However, for such items wh ere toll tax exemption is not granted as a rule, the payment of toll tax shall be made by the contr actor. However, any tax levied on goods like AGT levied by HP Govt. will be paid by the transport er and the reimbursement of the same to the contractor shall be made by the corporation agains t proof that has actually been paid.

# 8.0 <u>SUBMISSION OF BILLS:-</u>

8.1 The contractor shall submit fortnightly bills, complete in all respects supported by copies of the delivery receipt for the payment of their bills by the Rajban Cement Factory.

8.2 No bill will be entertained unless the contractor submits acknowledgemen t of the material delivered signed by the consignees in respect of each and eve ry consignment, duly indicating the GP No. date of delivery and certifying that t he material has been received in good condition and in full quantity.

# 9.0 **DURATION OF THE CONTRACT:-**

The contract shall remain in force for a period of one year from the date of award of work order and may be extended for another one year on the same rates terms and conditions for the same quantity on mutual consent of the party/parties. The contract validity period shall be extended s uitably to complete the outstanding quantity against the indent/work order placed, if required.

# 10.0 PAYMENT TERMS:-

Payment will be made within 15 days by RTGS/NEFT after receipt of material subject to submissi on of the relevant bills by the party along with the relevant documents after relevant deduction s /any tax as per Govt. rules.

# 11.0 SHORT CLOSURE OF THE CONTRACT:-

CCI reserves the right to short close the contract at any stage without assigning any reason ther eof. However, CCI shall give 3 days' notice for the same. No compensation whatsoever on any ac count shall be paid by CCI in the event of short closure of the contract.

# 12.0 SECURITY DEPOSIT :-

Security deposit @ 5% of the value of the contract should be deposited wi thin 15 days after award of LOI / Work order in the form of BG/DD/FDR fro m any Government/Nationalized bank.

# 13.0 E-way bill if required during transportation will be arranged by th e suppler.

### 14.0 <u>EMD</u>:-

**₹ 145000/- (Rupees one lakh forty five thousands only)** to be paid through online mode only with Debit Card, Credit Card & NEFT/RTGS. S SI units registered with NSIC, MSME and Public Sector Undertakings are exempted from furnishing EMD only.

## 15.0 ELIGIBILITY CRITERIA:

- **15.1** Supplier should have GST no and PAN card.
- **15.2** The supplier should possess suitable vehicles for transportation of Dry Fly Ash in good running condition for which necessary documentary evid ences such as photo copies of the RC books and Regn. ### 16.0 LABOUR LAWS:-
