In addition to the General Terms and Conditions of tender under PART – I & II, the following terms and conditions will also apply to the contract. These special terms and conditions, if contradictory to any conditions given in PART - I & II, will prevail upon the conditions given therein.

1.0 BRIEF DESCRIPTION OF PLANT AND ROPEWAY:

Bokajan Cement Plant (BCF) is a unit of Cement Corporation of India Ltd, Government of India Enterprises under the Ministry of Heavy Industries. Bokajan Cement Factory went into commercial production in 1977. Plant is situated at Bokajan, Karbi Anglong, Assam on the NH-39 (Golaghat Road) which is connecting to the site with Dimapur on South and Golaghat on North through the Bokajan town. Plant is well connected by Rail and Road; it is 1.4 Km far from Bokajan Railway station, 10Km from Dimapur Railway Station and the nearest airport is Dimapur at 18KM. Bokajan Cement factory is having its own Railway siding (CCIB) adjacent to Factory.

Bokajan Cement Plant is having bi-cable ropeway for transportation of limestone from mines to plant. Length of ropeway is 18 KM. Distance between plant to mines is 28 KM by road.

2.0 SCOPE OF WORK

Partial outsourcing of crusher area cleaning, ropeway line maintenance and bucket repair etc. work through job contract covering ropeway and crusher area. The job includes:-

- i) Ropeway line inspection at 04 location between loading station to unloading station.
- ii) Periodic greasing and oiling of shoes/trestle from loading station to unloading station.
- iii) Trimming of vegetation as and when required between loading station to unloading station.
- iv) Trestles and TRD foundation cleaning between loading station to unloading station.
- v) Straightening of hanger of bucket assembly in unloading station.
- vi) Repairing of carriage body in unloading station.
- vii) Alignment and repair of buckets in unloading station.
- viii) Repair and assembly of wheel in unloading station.
- ix) Assembly of buckets and shifting to sick line in unloading station/angle station/loading station.
- x) Collection of buckets from ropeway line

- xi) Cleaning of crusher spillage material and related area at mines
- xii) Cleaning of crusher conveyor belt spillage material at mines .

3.0 EXPERIENCE

The bidder should be well experienced in the line of work under consideration. In proof of the same the bidder should furnish documentary evidence such as Xerox copy of few work orders executed by them/certificate for satisfactory performance of the work issued to them for the work of similar nature with value

4.0 INSPECTION

Our corporation representative may visit the worksite anytime and any number of same. Any defect in workmanship will have to be redone. However, contractor has to maintain job register for day to day job record and same has to verify by section in-charge on daily basis. This record must be submitted along with monthly bill for verification purpose.

5.0 SAFETY

- i) The contractor will not employ workers below 18 years of age. All workers deployed in the job under him must be covered by insurance for any eventualities. The company will not be a party to any liabilities of the contractor employees; arising out of accidents, deaths, or any other circumstances.
- ii) All workers must be physically fit; certified by a government doctor. Certificate not necessary to be submitted but should be able to produce on demand.
- iii) No worker will report to duty under intoxication. All worker shall bear in himself an ID proof provided by contractor.
- iv) Above 1.8 meters the worker will use safety harness to secure themselves. Helmet and safety shoe must be provided by the contractor and should be available with workers. Penalty of Rs. 500/- per person will be charged for each unsafe act.
- v) A supervisor must be present during the working hours at the job site and the safety of the worker will be sole responsibility of the contractor.
- vi) Prior to the operation of the contractor, all the workers employed by the contractor must be educated on the precautions to be taken on the operational and maintenance aspect of the ropeway.

6.0 DURATION OF CONTRACT

01 year from the date of receipt of work-order. The contract has a provision for extension for another 01 year after satisfactory completion of first year with same terms and conditions including rates.

7.0 MOBILIZATION

You are requested to mobilize manpower within 07 days from receipt of work order.

8.0 SUPERVISIOR

The contractor should engage skilled supervisor to supervise the work to be executed by him at his own

cost. The contractor shall have to make himself or his responsible representative available at the working place during the working time to contact the concerned officer of the department for taking instructions.

9.0 REWORK

Rework cost arising due to error of the contractor will not be borne by CCI. Consumables used for the rework will be deducted from the monthly bill.

10.0 TOOLS AND TACKLES

Special tools and tackles may be provided by CCI to the contractor but it will be subject to availability. Regular tools, such as screw drivers, wrenches, pliers, adjustable spanners, dry cell LED torch, oil can, plastic jerry cans, raincoat/umbrellas, boots etc. shall be in the purview of the contractor. Any employee of contractor engaged in the line duty shall have a mobile phone for communication. The phone number and names must be given to all stations (loading, angle and unloading) and to ropeway officials before the commencement of duty.

Welding machine with cable, welding electrodes, oxygen & DA gas, cutting set, grease, other consumables etc. will be provided by CCI.

11.0 ACCOMODATION

The contractor employees are not entitled for accommodation or to any other facility as applicable to company employees.

12.0 PRICE

Price quoted in tender shall remain firm till the end of the contract period including all authorised extensions of the time for completing the work as may be sanctioned by the corporation from time to time.

13.0 GOODS & SERVICE TAX

- i) The IGST/CGST/SGST, if applicable, will be paid on the cost of the finished goods being supplied, as per the rate (%) prevailing at the time of scheduled delivery period, subject to the supplier claiming the same as separate item on their bill.
- ii) The supplier shall furnish the following certificate on the body of the bill claiming aforesaid amount of IGST/CGST/SGST.
- iii) "It is certified that the goods, on which GST has been charged, have not been exempted under the GST or the rules made there under. The amount charged on account of GST on those goods are not more than what is payable under the provision of the relevant act or the rules made there under: "
- vi) GST will be paid subject to showing/appearing the same on GST portal under GSTR-2A report.

14.0 SUBMISSION OF BILLS

Bills to be submitted on monthly basis by 07th of each month.

15.0 PAYMENT TERMS

The payment shall be released on monthly basis to the contractor as per actual measurement of the work and clearance of engineer in-charge. The bill shall be submitted by the contractor before 7th of the month. The payment to the contractor will be released based on bill of quantities of the work completed in all respect as per tender specification per unit basis or part thereof fully certified by CCI. The Payment will be released with 15 days from date of submission of monthly bill through RTGS/NEFT.

16.0 PAYING AUTHORITY

17.0 **PENALTY / L.D.**

The deployment of contractual workers shall be made within 7 days of placing the order. Time is of essence in this context and therefore, in case of any failure on the part of the successful bidder to deploy the required contractual workers within the specified time, a penalty shall be imposed @ 0.5 % per fortnight subject a maximum 5% of contract value.

In the event of non-performance or poor performance of the work by the workman or any man made delay or damage due to negligence of the worker an amount equal to the cost to re-do the work to make it good will be charged as penalty and will be deducted from the running RA bill. No separate communication will be given to the contractor in this regard. Therefore, contractor has to keep sharp eye on the manpower deployed for their performance.

The completion of the job within the stipulated time is the essence of the contract and service must be performed within the time and subject to conditions specified. For any breach of contract, the corporation will be entitled to take any other course of action against the contractor as it may deem fit like debarring from tendering, stoppage of business dealing etc.

Further CCI reserves the right to cancel the order at risk and cost of the supplier, without any further reference to the successful bidder.

18.0 STATUTORY REQUIREMENT

The tender should be accompanied by labour licence, ESIC, IT, PAN & GST reg. no. The contractor shall be responsible for fulfilling all the statutory requirements (related to this contract) as deemed necessary by different agencies. The contractor will bear all cost for above statutory requirement.

19.0 RULES AND REGULATION

The contractor should follow strictly all the Rules and Regulations of the Corporation as well as the regulatory/statutory, Local Authority in connection with the contract. The contractor will be held responsible for any violation of the Rules and Regulations of the Corporation and regulatory/statutory authority.

20.0 DISCIPLINE

The contractor should see that all his workman including supervisor and himself should behave properly in carrying out the work in orderly manner so that all kinds of indiscipline be avoided, in case of any indiscipline noticed among the workman or any damage caused to the equipments, the Corporation is bound to take action to stop the employees from the work or to terminate the contract as deemed fit by the Corporation along with the right to recover the damaged from the dues payable to the Contractor..

21.0 ACCIDENT

The contractor shall be liable for compensation to his labours payable under the Workman's Compensation Act, 1923 or any other Act in case of accident. In case he fails to pay the compensation, the Corporation reserves the right to make the payment and recover the same from any of his bills or Security Deposit. The contractor must obtain Licence from the Labour Licening Authority before starting the work / fifteen days time of receiving LOI. Labour Licence and Insurance premium will be liability of the contractor. However, insurance premium will be reimbursed by the corporation.
