SPECIAL TERMS & CONDITIONS OF CONTRACT

1.0 SCOPE OF WORK: for Internal Audit of Energy Management System (EnMS):-

1. The scope of work for the internal audit of the Energy Management System (EnMS) includes; but is not limited to the following:

- 1.1 Evaluating conformity to ISO 50001:2018 requirements.
- 1.2 Assessing the effectiveness and efficiency of the EnMS.
- 1.3 Identifying areas of improvement and potential energy performance opportunities.
- 1.4 Reviewing compliance with legal and other requirements.
- 1.5 Verifying the implementation, maintenance, and continuous improvement of the EnMS.

2. Audit Process:

- 2.1 Document review.
- 2.2 Interviews with personnel.
- 2.3 Observation of operational practices.
- 2.4 Review of records and documentation.

3. Audit Deliverables:

- 3.1 A comprehensive audit report detailing findings, recommendations, and action plans.
- 3.2 Presentation of audit results to management.
- 3.3 Identification of potential energy performance improvement opportunities.

4. Conduct Management Review:

- 4.1 Review of audit findings and recommendations.
- 4.2 Discussion of implementation and corrective actions.
- **4.3** Approval of action plans and responsibilities.

5.0 Eligibility criteria for an internal auditor as per EnMS (Energy Management System)::-

- 5.1. BEE Certification: The auditor must possess a certification from the Bureau of Energy Efficiency (BEE) as an Energy Manager (EM) or Energy Auditor (EA).
- 5.2 Experience: The auditor must have: Executed at least 2 BEE EnMS (Energy Management System) projects. Executed an EnMS project through the Quality Council of India (QCI) in any cement plant.
- 5.3 IRCA Accreditation: The auditor must be a trained ISO 50001:2018 consultant, accredited by the International Register of Certificated Auditors (IRCA).
- 5.4. Education: The auditor must have a postgraduate degree in either: M.Tech (Master of Technology) in Energy Management **or** MBA (Master of Business Administration) in Energy Management.

6.0. Terms of Payment:

- No advance payment shall be made.
- Successful tenderer shall submit audit report along with bill.
- 90 % payment after deduction of applicable taxes shall be made within 30 days after completion of work & submission of invoice duly certify by HOD(Electrical).
- **6.1 Security Deposit** @ 10 % of value of work order including all taxes shall be kept as security deposit
- 6.2 **Liquidated Damages**: L.D. will be levied @ ½% of the work value or part thereof for per week Delay on unexecuted job, subjected to maximum of 5%.
- 7. Documents required to be submitted along with Techno-commercial Bid:-
- 7.1 Scanned copy of covering letter (Annexure-1)
- 7.2 Copy of GST Registration Certificate and PAN Card
- 7.3 Signed and stamped Scanned Copy of Part-III- Special terms & conditions,
- 7.4 Signed and stamped Scanned Copies of documents as per eligibility criteria.
- 8. **Transportation** /**Lodging and boarding**: To and Fro charges shall be borne by the successful tenderer. However, CCI will provide local conveyance and free lodging and boarding at their Guest House/Transit Guest House only.
- 9. Periodicity of contract: The validity of the contract shall be initially for a period of two years, with an option for a one-year extension from the date of award of work. The rates quoted shall remain firm for the entire contract period, including the extension period.
- 9.1 Number of Visits for Audit: Two visits are required per year for internal audit and each internal audit visit shall comprise a minimum of "04 days" to completely cover the defined scope & boundary as per existing EnMS System. The internal audit dates will be confirmed by the Head of Department (Electrical) as per the stipulated frequency.
- 10. The contract will be subject to extension for equal period, if CCI deserve so on the same rates, terms and conditions.
- 11. Tenderer shall ensure, before quoting the rates, that they have considered the requirements of Clause No. 5 and 9. In case of underestimation, no requests will be entertained at any stage of the tender process
- 12. In case of any dispute in regard to the contract, the jurisdiction shall be the court Of Paonta sahib.
