COMPOUND OVER INSULATORS OF 132 KV SUBSTATION BAY-I & BAY-II.**

1) Scope Of Work:

- a. The insulators are mounted above the ground level of 3 meters of each structure. For cleaning of insulators supporting arrangements has to be prepared for safe working of the workmen.
- b. While cleaning the insulators, proper care should be taken so that the insulators are not damaged. The dust / cement material deposited over the insulator surface is to be thoroughly removed by chipping / using wire brush, metal strips etc. without damaging the insulators to get the glazed surface.
- c. After thorough cleaning of the insulator, Anti-tracking compound is to be applied after taking clearance from the section In-charge.
- d. The material required for safe working and for proper support arrangement such as wooden poles etc. shall be provided by CCI.
- e. Shut-down clearance to be taken from the SBA before starting of the work and ensure the earthing of 3 phases.

2) Supply & Applying of Anti Tracking Compound:

- a. Anti tracking compound should be of reputed make with ISI mark.
- b. It should be of silicon compound-D for dielectric, anti tracking, high temperature & lubrication.

3) Duration Of Contract:

The contract will be for a period of Two (02) years. The prices shall remain firm throughout the tenure of the contract i.e. for a period of Two (02) years. However, the contract can be extended further for a period of one year at the same rates, terms & conditions at the discretion of the management.

4) Time Frame:

The entire work should be completed in all respects once in every year within duration of 132 KV Substation line shutdown as per the schedule prepared by CCI Engineer.

5) EXPERIENCE / ELIGIBILITY CRITERIA:
