Preamble:

The Principal intends to award, under laid down organizational proced ures, contract/s for ------The Principal value full complianc e with all relevant laws of the land, rules, regulations, economic use of resources and of fairness / transparency in its relations with its Bidder(s) and / or Contractor(s). In order to achieve these goals, the Pr incipal will appoint an Independent External Monitor (IEM), who will m onitor the tender process and the execution of the contract for complia nce with the principles mentioned above. Section 1 - Commitments of t he Principal

1) The Principal commits itself to take all measures necessary to preve nt corruption and to observe the following principles:-

a) No employee of the Principal, personally or through family members , will in connection with the tender for, or the execution of a contract, demand, take a promise for or accept, for self or third person, any mat erial or immaterial benefit which the person is not legally entitled to.

b) The Principal will, during the tender process treat all Bidder(s) with equity and reason, The Principal will in particular, before and during t he tender process, provide to all Bidder(s) the same information and w ill not provide to any Bidder(s) confidential additional information thro ugh which the Bidder(s) could obtain an advantage in relation to the te nder process or the contract execution.

d) The Bidder(s)/Contractor(s) of foreign origin shall disclose the name and address of the Agents/representatives in India, if any. Similarly th e Bidder(s)/Contractor(s) of Indian Nationality shall furnish the name a nd address of the foreign principals, if any, Further details as mention ed in the "Guidelines on Indian Agents of Foreign Suppliers' shall be di sclosed by the bidder(s) / Contractor(s). Further, as mentioned in the G uidelines all the payments made to the Indian agent/representative ha ve to be in 'Indian Rupees only.

e)The Bidder(s)/Contractor(s) will, when presenting his bid, disclose an y and all payments he has made, is committed to or intends to make to agents, brokers or any other intermediaries in connection with the aw ard of the contract

f) The Bidder(s)/Contractor(s) will not instigate third persons to commi t offences outlined above or be an accessory to such offences.

g) Bidder(s)/Contractor(s) signing IP shall not approach the court while representing the matters to IEMs and he/she will await their decision i n the matter.

h) In case of a joint venture, all the partners of the joint ventures to si gned the IP

i) Any violation of Integrity Pact would entail disqualification of the Bidders and exclusion from future business dealings, as per the existin g Provision of GFR, 2017, PC act, 1988 and other Financial Rules/Guidelines etc. as may be applicable to the origination concerne d.

j) In the event of any dispute between the management and the contra ctor relating to those contracts where integrity pact is applicable, in c ase, both the parties are agreeable, they may try to settle dispute thro ugh mediation before the panel of IEMs in a time bound manner. If req uired the Organizations may adopt any mediation rule for this purpose. In case, the dispute remains unresolved even after mediation by the p anel Of IEMs, the organizations may take further action as per the ter ms & Conditions of the contract.

Section 3-Disqualification from tender process and exclusion from futu re contracts :

- (1) If the Bidders(s)/Contractor(s), before award or during execution h as committed a transgression through a violation of Section 2, abov e or in any other form such as to put his reliability or credibility in q uestion, the principal is entitled to disqualify the Bidder(s)/Contract or(s) from the tender process or to terminate the contract, if alread y signed for such reason.
- (2) If the Bidder/Contractor has committed a serious transgression thr ough a violation of sector-2 such as to put his reliability or credibilit y into question, the principal is entitled also to exclude the Bidder/C ontractor from future contract award processes. The imposition an d duration of the exclusion will be determined by the severity of th e transgression. The severity will be determined by the circumstanc es of the case, in particular the number of transgressions, the positi on of the transgressors with the company hierarchy of the Bidder a nd the amount of the damage. The exclusion will be imposed for a minimum of 6 months and maximum of 3 years.
- (3) If the Bidder/Contractor can prove that he has restored/recouped t he damage caused by him and has installed a suitable corruption pr evention system, the Principal may revoke the exclusion prematurel y.
- (4) A transgression is considered to have occurred if in light of availa ble evidence no reasonable doubt is possible.

Section 4 - Compensation for Damages :

(1) If the Principal has disqualified the Bidder(s) from the tender proce ss prior to the award according to Section 3, the Principal is entitled to demand and recover the damages equivalent to Earnest Money Deposi t/ Bid Security. (2) If the Principal has terminated the contract according to Section 3, or if the Principal MM entitled to terminate the contract according to S ection 3, the Principal shall be entitled to demand and recover from th e Contractor liquidated damages of the Contract value or the amount e quivalent to Performance Bank Guarantee.

Section 5 -Previous transgression:

- (1) The Bidder declares that no previous transgressions occurre d in the last 3 years with any other Company in any country co nforming to the anti-corruption approach or with any other Pu blic Sector Enterprise in India that could justify his exclusion fr om the tender process.
- (2) If the Bidder makes incorrect statement on this subject, he c an be disqualified from the tender process.

Section 6- Equal treatment of all Bidders/Contractors/Sub-contractors :

(1) The Bidder(s)/ Contractor(s) undertake(s) to demand from all subco ntractors the commitment consistent with this Integrity Pact, and to su bmit it to the Principal before contract signing.

(2) The Principal will enter into agreements with identical conditions a s this one with all Bidders and Contractors.

(3) The Principal will disqualify from the tender process all bidders wh o do not sign this Pact or violate its provisions.

Section-7- Criminal charges against violating bidder(s)/Contactor(s)/Su bcontractors:

If the Principal obtains knowledge of conduct of a Bidder, Contractor o r Subcontractor, or of an employee or a representative or an associate of a Bidder, Contractor or Subcontractor which constitutes corruption, or if the Principal has substantive suspicion in this regard, the Principa I will inform the same to the Chief Vigilance Officer.

Section 8 -Independent External Monitor/Monitors :

(1) The Principal appoints competent and credible Independent Ext ernal Monitor for this Pact. The task of the Monitor is to review in dependently and objectively, whether and to what extent the part ies comply with the obligations under this agreement.

(2) The Monitor is not subject to instructions by the representatives

of the parties and performs his functions neutrally and independently. He reports to the Chairman, CCI.

- (3) The Bidder(s)/Contractor(s) accepts that the Monitor has the rig ht to access without restriction to all tender documentation of th e Principal including that provided by the Contractor. The Contra ctor will also grant the Monitor, upon his request and demonstrat ion of a valid interest, unrestricted and unconditional access to hi s project documentation. The same is applicable to Subcontractor s. The Monitor is under contractual obligation to treat the inform ation and documents of the Bidder(s)/Contractor(s)/Subcontractor r(s) with confidentiality.
- (4) As soon as the Monitor notices, or believes to notice, a violation of this agreement, he will so inform the Management of the Principal and request the Management to discontinue or take corr ective action, or to take other relevant action. The monitor can in this regard submit nonbinding recommendations. Beyond this, th e Monitor has no right to demand from the parties that they act i n a specific manner, refrain from action or tolerate action. Howev er, the independent External Monitor shall give an opportunity to the Bidder/Contractor to present its case before making its recom mendations to the Principal.
- (5) The Monitor will submit a written report to the Chairman, CCI wi thin 5 to 10 weeks from the date of reference or intimation to hi m by the Principal and, should the occasion arise, submit proposa Is for correcting problematic situations.
- (6) Monitor shall be entitled to compensation on the same terms as being extended to / provided to Independent Directors on the CCI Board.
- (7) If the Monitor has reported to the Chairman CCI, a substantiated suspicion of an offence under relevant IPC/PC Act, and the Chair man, CCI has not, within the reasonable time taken visible action to proceed against such offence or reported it to the Chief Vigilance Officer, the Monitor may also transmit this information directly to the Central Vigilance Commissioner.
- (8) The word 'Monitor/ would include both singular and plural.

- (9) Independent External Monitor shall be required to maintain conf identially of the information acquired and gathered during their t enure/role as independent Monitor. Any breach in this regard wo uld be subject to the legal judicial system of India.
- (10) Independent External Monitor(s) shall be required to fur nish an Undertaking and disclose before taking any assignment t hat he/she has no interest in the matter or connected with the pa rty (Bidder/Contractor) in any manner.

Section 9 — Pact duration :

This pact begins when both parties have legally signed it. It expires fo r the Contractor 12 months after the last payment under the contract and for all other bidders 6 months after the contract has been awarde d. If any claim is made/lodged during this time, the same shall be bindi ng and continue to be valid despite the lapse of this pact as specified above, unless it is discharged/determined by Chairman of CCI.

Section 10 — Other provisions:

- (1) This agreement is subject to Indian Law. Place of performance and jurisdiction is the Registered Office of the Principal, i.e. New Delhi.
- (2) Changes and supplements as well as termination notices need to b e made in writing. Side agreements have not been made.
- (3) If the Contractor is a partnership or a consortium, this agreement must be signed by all partners or consortium members.
- (4) Should one or several provisions of this agreement turn out to be i nvalid, the remainder of this agreement remains valid. In this case, the parties will strive to come to an agreement to their original inte ntions.
