1. Preference to Make In India products (For bids < 200 Crore):Preference shall be given to Class 1 local supplier as defined in public procurement (Preference to Make in India), Order 2017 as amended from time to time and its subsequent Orders/Notifications issued by concerned Nodal Ministry for specific Goods/Products. The minimum local content to qualify as a Class 1 local supplier is denoted in the bid document. If the bidder wants to avail the Purchase preference, the bidder must upload a certificate from the OEM regarding the percentage of the local content and the details of locations at which the local value addition is made along with their bid, failing which no purchase preference shall be granted. However, eligible micro and small enterprises will be allowed to participate .The buyers are advised to refer the OM No.F.1/4/2021-PPD dated 18.05.2023. <u>OM No.1 4 2021 PPD dated 18.05.2023</u> for compliance of Concurrent application of Public Procurement Policy for Micro and Small Enterprises Order, 2012 and Public Procurement (Preference to Make in India) Order, 2017.

2. Purchase preference will be given to MSEs having valid Udyam Registration and whose credentials are validated online through Udyam Registration portal as defined in Public Procurement Policy for Micro and Small Enterprises (MSEs) Order, 2012 dated 23.03.2012 issued by Ministry of Micro, Small and Medium Enterprises and its subsequent Orders/Notifications issued by concerned Ministry. If the bidder wants to avail themselves of the Purchase preference, the bidder must be the manufacturer / OEM of the offered product on GeM. Traders are excluded from the purview of Public Procurement Policy for Micro and Small Enterprises and hence resellers offering products manufactured by some other OEM are not eligible for any purchase preference. In respect of bid for Services, the bidder must be the Service provider of the offered Service. Relevant documentary evidence in this regard shall be uploaded along with the bid in respect of the offered product or service and Buyer will decide eligibility for purchase preference based on documentary evidence submitted, while evaluating the bid. If L-1 is not an MSE and MSE Seller (s) has / have quoted price within L-1+ 15% (Selected by Buyer) of margin of purchase preference /price band defined in relevant policy, such MSE Seller shall be given opportunity to match L-1 price and contract will be awarded for 25% (selected by Buyer) percentage of total quantity. The buyers are advised to refer the OM No. F.1/4/2021-PPD dated 18.05.2023 OM No.1 4 2021 PPD dated 18.05.2023 for compliance of Concurrent application of Public Procurement Policy for Micro and Small Enterprises Order, 2012 and Public Procurement (Preference to Make in India) Order, 2017. Benefits of MSE will be allowed only if seller is validated on-line in GeM profile as well as validated and approved by Buyer after evaluation of documents submitted.

OPTION CLAUSE: The Purchaser reserves the right to increase or decrease the quantity to be ordered up to 25 percent of bid quantity at the time of placement of contract. The purchaser also reserves the right to increase the ordered quantity up to 25% of the contracted quantity during the currency of the contract at the contracted rates. The delivery period of quantity shall commence from the last date of original delivery order and in cases where option clause is exercised during the extended delivery period the additional time shall commence from the last date of extended delivery period. The additional delivery time shall be (Increased quantity \div Original quantity) \times Original delivery period (in days), subject to minimum of 30 days. If the original delivery period is less than 30 days, the additional time equals the original delivery period. The Purchaser may extend this calculated delivery duration up to the original delivery period while exercising the option clause. Bidders must comply with these terms.

INTEGRITY PACT

Between Cement Corporation of India Limited (CCI) hereinafter referred to as "T he Principal", and ------hereinafter referred to as " The Bidder/Contractor" Preamble:

The Principal intends to award, under laid down organizational procedures, contr act/s for ------The Principal value full compliance with all relevant law s of the land, rules, regulations, economic use of resources and of fairness / tran sparency in its relations with its Bidder(s) and / or Contractor(s). In order to achi eve these goals, the Principal will appoint an Independent External Monitor (IEM) , who will monitor the tender process and the execution of the contract for comp liance with the principles mentioned above. Section 1 - Commitments of the Prin cipal

1) The Principal commits itself to take all measures necessary to prevent corrupt ion and to observe the following principles:-

- a) No employee of the Principal, personally or through family members, will in co nnection with the tender for, or the execution of a contract, demand, take a p romise for or accept, for self or third person, any material or immaterial bene fit which the person is not legally entitled to.
- b) The Principal will, during the tender process treat all Bidder(s) with equity an d reason, The Principal will in particular, before and during the tender proces s, provide to all Bidder(s) the same information and will not provide to any Bi dder(s) confidential additional information through which the Bidder(s) could obtain an advantage in relation to the tender process or the contract executi on.
- c) The Principal will exclude from the process all known prejudiced persons. (2) I f the Principal obtains information on the conduct of any of its employees whi ch is a criminal offence under the IPC/PC Act, or if there be a substantive suspicion in this regard, the Principal will inform the Chief Vigilance Officer an d in addition can initiate disciplinary actions.

Section 2 - Commitments of the Bidder(s)/ contractor(s) :

The Bidder(s)/ Contractor(s) commit himself to take all measures necessary to p revent corruption. He commits himself to observe the following principles during his participation in the tender process and during the contract execution.

- a) The Bidder(s)/Contractor(s) will not, directly or through any other person or fir m, offer, promise or give to any of the Principal's employees involved in the te nder process or the execution of the contract or to any third person any mater ial or other benefit which he/she is not legally entitled to, in order to obtain in exchange any advantage of any kind whatsoever during the tender process or during the execution of the contract.
- b) The Bidder(s)/Contractor(s) will not enter with other Bidders into any undisclo sed agreement or understanding, whether formal or informal. This applies in p articular to prices, specifications, certifications, subsidiary contracts, submissi on or non-submission of bids or any other actions to restrict competitiveness o r to introduce cartelization in the bidding process.
- c) The Bidder(s)/Contractor(s) will not commit any offence under the relevant IP C/PC Act; further the Bidder(s)/ Contractor(s) will not use improperly; for purpo se s of competition or personal gain, or pass on to others, any information or d ocument provided by the Principal as part of the business relationship, regard ing plans, technical proposals and business details, including information cont ained or transmitted electronically.

- d) The Bidder(s)/Contractor(s) of foreign origin shall disclose the name and addr ess of the Agents/representatives in India, if any. Similarly the Bidder(s)/Contr actor(s) of Indian Nationality shall furnish the name and address of the foreign principals, if any, Further details as mentioned in the "Guidelines on Indian Ag ents of Foreign Suppliers' shall be disclosed by the bidder(s) / Contractor(s). F urther, as mentioned in the Guidelines all the payments made to the Indian ag ent/representative have to be in 'Indian Rupees only.
- e)The Bidder(s)/Contractor(s) will, when presenting his bid, disclose any and all payments he has made, is committed to or intends to make to agents, broker s or any other intermediaries in connection with the award of the contract
- f) The Bidder(s)/Contractor(s) will not instigate third persons to commit offences outlined above or be an accessory to such offences.
- g) Bidder(s)/Contractor(s) signing IP shall not approach the court while represent ing the matters to IEMs and he/she will await their decision in the matter.
- h) In case of a joint venture, all the partners of the joint ventures to signed the IP
- i) Any violation of Integrity Pact would entail disqualification of the Bidders and exclusion from future business dealings, as per the existing Provision of GFR, 2017, PC act, 1988 and other Financial Rules/Guidelines etc. as may be applic able to the origination concerned.
- j) In the event of any dispute between the management and the contractor relating to those contracts where integrity pact is applicable, in case, both the parties are agreeable, they may try to settle dispute through mediation before the panel of IEMs in a time bound manner. If required the Organizations may adop t any mediation rule for this purpose. In case, the dispute remains unresolved even after mediation by the panel Of IEMs, the organizations may take further action as per the terms & Conditions of the contract.

Section 3-Disqualification from tender process and exclusion from future contrac ts :

- (1) If the Bidders(s)/Contractor(s), before award or during execution has commit ted a transgression through a violation of Section 2, above or in any other for m such as to put his reliability or credibility in question, the principal is entitl ed to disqualify the Bidder(s)/Contractor(s) from the tender process or to ter minate the contract, if already signed for such reason.
- (2) If the Bidder/Contractor has committed a serious transgression through a violation of sector-2 such as to put his reliability or credibility into question, the principal is entitled also to exclude the Bidder/Contractor from future contract award processes. The imposition and duration of the exclusion will be determined by the severity of the transgression. The severity will be determined by the circumstances of the case, in particular the number of transgressions, the position of the transgressors with the company hierarchy of the Bidder and the amount of the damage. The exclusion will be imposed for a minimum of 6 months and maximum of 3 years.

(3) If the Bidder/Contractor can prove that he has restored/recouped the damag

e caused by him and has installed a suitable corruption prevention system, t he Principal may revoke the exclusion prematurely.

(4) A transgression is considered to have occurred if in light of available eviden ce no reasonable doubt is possible.

Section 4 - Compensation for Damages :

- (1) If the Principal has disqualified the Bidder(s) from the tender process prior to the award according to Section 3, the Principal is entitled to demand and rec over the damages equivalent to Earnest Money Deposit/ Bid Security.
- (2) If the Principal has terminated the contract according to Section 3, or if the P rincipal MM entitled to terminate the contract according to Section 3, the Prin cipal shall be entitled to demand and recover from the Contractor liquidated damages of the Contract value or the amount equivalent to Performance Ban k Guarantee.

Section 5 - Previous transgression:

- (1) The Bidder declares that no previous transgressions occurred in the last 3 ye ars with any other Company in any country conforming to the anti-corruption approach or with any other Public Sector Enterprise in India that could justify his exclusion from the tender process.
- (2) If the Bidder makes incorrect statement on this subject, he can be disqualifie d from the tender process.

Section 6- Equal treatment of all Bidders/Contractors/Sub-contractors :

- (1) The Bidder(s)/ Contractor(s) undertake(s) to demand from all subcontractors the commitment consistent with this Integrity Pact, and to submit it to the Principal before contract signing.
- (2) The Principal will enter into agreements with identical conditions as this one with all Bidders and Contractors.
- (3) The Principal will disqualify from the tender process all bidders who do not si gn this Pact or violate its provisions.

Section-7- Criminal charges against violating bidder(s)/Contactor(s)/Subcontract ors:

If the Principal obtains knowledge of conduct of a Bidder, Contractor or Subcont ractor, or of an employee or a representative or an associate of a Bidder, Contra ctor or Subcontractor which constitutes corruption, or if the Principal has substa ntive suspicion in this regard, the Principal will inform the same to the Chief Vigil ance Officer.

Section 8 -Independent External Monitor/Monitors :

(1) The Principal appoints competent and credible Independent External Monitor fo

r this Pact. The task of the Monitor is to review independently and objectively, w hether and to what extent the parties comply with the obligations under this agr eement.

- (2) The Monitor is not subject to instructions by the representatives of the parties a nd performs his functions neutrally and independently. He reports to the Chairm an, CCI.
- (3) The Bidder(s)/Contractor(s) accepts that the Monitor has the right to access wit hout restriction to all tender documentation of the Principal including that provid ed by the Contractor. The Contractor will also grant the Monitor, upon his reques t and demonstration of a valid interest, unrestricted and unconditional access to his project documentation. The same is applicable to Subcontractors. The Monit or is under contractual obligation to treat the information and documents of the Bidder(s)/Contractor(s)/Subcontractor(s) with confidentiality.
- (4) As soon as the Monitor notices, or believes to notice, a violation of this agreeme nt, he will so inform the Management of the Principal and request the Manageme nt to discontinue or take corrective action, or to take other relevant action. The monitor can in this regard submit nonbinding recommendations. Beyond this, th e Monitor has no right to demand from the parties that they act in a specific ma nner, refrain from action or tolerate action. However, the independent External Monitor shall give an opportunity to the Bidder/Contractor to present its case bef ore making its recommendations to the Principal.
- (5) The Monitor will submit a written report to the Chairman, CCI within 5 to 10 wee ks from the date of reference or intimation to him by the Principal and, should th e occasion arise, submit proposals for correcting problematic situations.
- (6) Monitor shall be entitled to compensation on the same terms as being extended to / provided to Independent Directors on the CCI Board.
- (7) If the Monitor has reported to the Chairman CCI, a substantiated suspicion of an offence under relevant IPC/PC Act, and the Chairman, CCI has not, within the rea sonable time taken visible action to proceed against such offence or reported it t o the Chief Vigilance Officer, the Monitor may also transmit this information dire ctly to the Central Vigilance Commissioner.
- (8) The word 'Monitor/ would include both singular and plural.
- (9) Independent External Monitor shall be required to maintain confidentially of the

information acquired and gathered during their tenure/role as independent Moni tor. Any breach in this regard would be subject to the legal judicial system of Ind ia.

(10) Independent External Monitor(s) shall be required to furnish an Undertaking an d disclose before taking any assignment that he/she has no interest in the matte r or connected with the party (Bidder/Contractor) in any manner.

Section 9 — Pact duration :

This pact begins when both parties have legally signed it. It expires for the Contr actor 12 months after the last payment under the contract and for all other bidd ers 6 months after the contract has been awarded. If any claim is made/lodged d uring this time, the same shall be binding and continue to be valid despite the la pse of this pact as specified above, unless it is discharged/determined by Chair man of CCI.

Section 10 — Other provisions:

- (1) This agreement is subject to Indian Law. Place of performance and jurisdiction is the Registered Office of the Principal, i.e. New Delhi.
- (2) Changes and supplements as well as termination notices need to be made i n writing. Side agreements have not been made.
- (3) If the Contractor is a partnership or a consortium, this agreement must be si gned by all partners or consortium members.

In addition to the general terms and conditions of the tender viz part I & II , the following special terms and conditions will also apply to the contract. The t erms & conditions if contradictory to any one given in part I & II the special term s and conditions of part II shall prevail upon such conditions.

1.0 SCOPE OF WORK :-

- 1.1 The contractor shall undertake loading, transportation of Gypsum as per inst ructions given by the concerned authority of Rajban Cement Factory and is t o be taken up immediately.
- 1.2 The contractor shall provide sufficient trucks as per delivery schedule/ instructions by production department for 2000 MT+/-25% Gypsum
- 1.3
 - a) The loading of Gypsum from NTPC Dadri and transportation to CCI Rajba n Cement Factory. CCI Rajban is situated at a distance of 10KM from Pao nta Sahib, Distt. Sirmour (H.P.) and Paonta Sahib is situated 60KM from Y amuna Nagar (Haryana). The transportation of fly ash shall also include th e following functions:
 - b) Weighment at NTPC dadri
 - b) Weighment of Trucks at NTPC dadri and CCI Ltd Rajban, the lowest of tw o the weight recorded will be taken for the payment purpose.
 - c) Unloading at CCI Rajban will be done by CCI.
- 1.4 No transshipment shall be done en-route, except in case of any break down f or which transporter has to take specific permission from CCI authorities.
- 1.5 Any damage due to the supplier/contractor or his vehicles/trucks/tippers at N TPC /CCIL will be the liability **of contractor** and the claimed amount will be recovered from the bills of the contractor as claimed by NTPC and CCI Ltd,Ra jban.

2.0 COST OF THE MATERIAL:

Cost of Gypsum will be in the scope of CCI.

3.0 **QUANTITY :-**

3.1 The approx. quantity of Gypsum to be transported is 2000 MT+/-25 %. How ever, the corporation reserves the right to divide the quantities between L-1, and L-2 tenderers in the ratio of 70:30, if L-2 tenderer match the L-1 rates. In case L-2 tenderers do not match the L-1 rates, option will be given to other t enderers starting from L-3,L-4...., to match L-1 rates and accordingly quantiti es will be divided in the ratio of 70:30 between L-1 tenderer and the tenderer r who match the L-1 rates. If L-2/L-3/L-4.... tenderer do not match the L-1 rate s, full quantity will be awarded to L-1 tenderer.

- 3.2 The quantity given is only indicative may vary $\pm 25\%$. The contractor shall n ot be entitled to have any claim or compensation whatsoever on this account
- 3.3 The corporation reserves the right to supply & transport the Gypsum in the t rucks owned/hired by CCI, if deemed necessary or to arrange other means of transport in case of urgency shall be the sole discretion of CCIL. The corpo ration reserves its right to carry the supply/ transport through other agency / contractor on the risk and cost of the supplier.

4.0 **QUALITY :-**

- a) Moisture for Gypsum maximum 20.0%
- b) If the moisture found more than specified, payment will be deducted on prorate basis on landed cost of material.

5.0 **<u>RATES:-</u>**

- 5.1 The rates should be quoted on per MT basis after considering the scope give n under clause no.1.0 (scope of work) and inclusive of all taxes, duties and ot her levies such as toll taxes, AGT etc. applicable en-route expenses up to Ra jban cement factory except GST on the transportation of material.. The rate quoted shall remain firm during the contract period or extension thereof. No revision in the rate on what so ever account may it be, shall be allowed.
- 5.2 The rates should be quoted for above scope of work (clause -1) of the part III – Special terms and conditions for the transportation of Gypsum from NTPC Dadri to Rajban cement Factory on per MT basis.
- 5.3 No detention or statistical charges shall be paid by the corporation.
- 5.4 The rates quoted shall remain firm for a period of one year & also for the extended period of contract, if any during the contract period.
- 5.5 In the event of negotiation only downward revision of rates will be allowed a ny change in techno commercial terms are agreed earlier will not be permitt ed at this stage. Any qualifying remarks in the price bid, revised/negotiated offer will not be entertained.

6.0 **PENALTY:-**.

- 6.1 The contractor shall ensure that the material is delivered within a maximum period of one day (24 hours) from the date of loading / taking delivery. In cas e of any delay, the penalty @ Rs. 10/- per MT will be levied from the contract ors' bill.
- 6.2 The supplier is required to place sufficient no. of trucks for transportation of Gypsum as per the delivery schedule / instructions given by CCI Rajban Prod uction department. For the short supply against delivery schedule will be levi ed LD @5% of the value of short supply .

7.0 SUBMISSION OF BILLS

- 7.1 The contractor shall submit fortnightly bills, complete in all respects support ed by copies of the delivery receipt for the payment of their bills by the Rajba n Cement Factory.
- 7.2 No bill will be entertained unless the contractor submits acknowledgement o f the material delivered signed by the consignees in respect of each and eve ry consignment, duly indicating the GP No. date of delivery and certifying tha t the material has been received in good condition and in full quantity.

8.0 **DURATION OF THE CONTRACT:**

The contract shall remain in force for a period of one year from the date of award of work order/ contract and the validity period shall be extended suit ably to complete the outstanding/ balance quantity, if any against the inden t/work order quantity.

Repeat order may be placed on the same rates, quantity, terms and conditions on sole discretion of the management.

9.0 PAYMENT TERMS AND PAYING AUTHORITY

- 9.1 Payment will be made within 15 days by RTGS/NEFT after receipt of material subject to submission of the relevant bills by the party along with the relevant documents after relevant deductions i.e. duties ,taxes as per Govt. rules.
- 9.2 Paying authority is HOD (Fin), CCI Rajban.

10.0 SECURITY DEPOSIT:-

Security deposit @ 5% of the value of the contract should be deposited wit hin 15 days after award of LOI / Work order in the form of BG/DD/FDR from any Government/Nationalized bank.

11.0 **REFUND OF SECURITY DEPOSIT**-

Security deposit of the contractor will be refunded within three month from the date of satisfactory completion of the contract.

12.0 E-way bill if required during transportation will be arranged by the suppler.

13.0 **EMD:-** Rs. 44000/- (Rupees forty four thousand only) to be paid through online mode only with Debit Card, Credit Card & NEFT/RTGS .SSI units registered with NSIC, MSME and Public Sector Undertakings are exempted f rom furnishing EMD only.

14.0 **ELIGIBILITY CRITERIA:**

- a) Transporter should have GST no and PAN card
- b) The supplier should possess vehicles in good running condition for which necessary documentary evidences such as photo copies of the RC books and Regn. No. of the vehicles may be furnished along with the techno-co mmercial bid of the tender. In case the vehicles are hired, the certificates from the concerned authority/ company from whom the vehicles are hire d indicating the period of hiring along with Regn. No. and RC books of the vehicles may be furnished.

15.0 LABOUR LAWS:-

17.0 In case disinvestments takes place during the contract period, the contract s hall stand terminated from that date. No claim or compensation will be ente rtained on this ground from contractor.
