PART III (Special term & conditions)

Sub: Engaging of one Mobile Crane of 25 MT capacity along with driver at CCI Tandur unit.

I. Scope of Work and other terms and conditions:

1. Engaging of one Mobile Crane of 25 MT capacity along with driver for lifting and lowering of heavy objects/equipments and for other miscellaneous works in the plant. The crane to be provided/available during all 7 days in a week. The crane should be parked inside factory premises after working hour. The availability of driver should be made in case of absenteeism due to any reason. The crane should be available in plant for 24 x 7. The crane should mobilized to CCI site within one week from the date of placement of Work Order.
2. Spares and tools required for maintenance of the crane have to be arranged by the contractor at his cost. Diesel will arranged by CCI.
3. The contractor should ensure that the crane engaged is in healthy & working condition, to avoid any breakdown during the operation. In case of any breakdown, the contractor should immediately arrange for its repair or arrange for another crane so that the work should not be get affected. The fitness certificate for the crane from statutory authorities should be submitted. Contractor is further responsible for the safety of his workmen, machine and material in the plant.
4. Workmen's compensation Act and other statutory laws in this connection i.e., Insurance of his employees against accidents etc are to be complied by the contractor). Corporation is not responsible for any accident etc to the workmen or any damage to crane etc. engaged by the contractor.
5. While working at site proper care should be taken to avoid the damage to the property of CCI and in case, occurrence of any incident to any person of CCI or damage to the property of CCI, all the expenditure should be borne by the contractors and CCI is not responsible for the same.
6. All insurance coverage should be arranged by the contractor for crane, and driving license for heavy vehicles to driver should be submitted before commencement of work and the driver should show the same at any time to the officials of CCI during his working time.
7. The contractor and his men should comply rules of safety and security prevailing at CCI premises.
8. The contractor has to adopt all measures for providing safety equipments for safe working of his employees inside the factory. All the labours engaged by the contractor for the above work should wear personal protective equipment.
9. The contractor shall ensure that no person should be engaged for the above work who is below the age of 18 years or has attained the age of 58 years.
10. The contractor is fully responsible for safety of his equipment as well as the properties of Corporation.

11. In case of non-execution of work / job as per work order, CCI reserves the right to get the work done by engaging other agencies at your risk & cost.

12. Accommodation for labours will be arranged by the Contractor / tenderer at his own cost. Accommodation for Staff will be arranged by the M/s. CCI on chargeable basis subject to availability.

13. The crane should be available at site 30 days in a month round the clock. Engagement of crane shall be, CASE I : 240 hours in a month or CASE II : 120 hours in a month which is mentioned in the Price Bid. Daily hours meter reading should be submitted to the Engineer-in-charge. The break down period will not be counted and Corporation will not pay any amount either for the break down period or for the alternative arrangement made in case of breakdown of the crane.

III. Duration of Contract : The contract is valid for (6) SIX months from the date of LOI/Work Order and In case the work is not allocated due to any reason, the time period shall be extended accordingly. However management has right to shortclose the contract in case the services are not required by giving a notice of 7 days. CCI reserve its right to extend the contract for further 6 months if requirement arises.

IV. Rate: Should be quoted lumpsum/month: The rate quoted shall remain firm during the period of contract/and extended period of the contract from the date of award of work. GST applicable should be mentioned clearly in their price bid. If tax element is not separately mentioned in the price bid, it will be assumed that the rate offered inclusive of tax. No escalation in the rate after award of work order will be entertained during the period of contract / extended period. The contractor's quoted rate should be inclusive of labour rate, tools and tackles required for completion of tender work. If crane/driver is not available , deduction will be made on prorata basis.

V. EMD : NIL

VI. Security Deposit: Security Deposit will be 5% of total contract value and will be refunded after 3 months of successful completion of the order.

VII. Payment : Payment will be released by way of RTGS within (15) fifteen days after submission of the bills for the work completed in all respects to HOD (Mech) CCI, Tandur. Contractor will submit the bill monthly. Payment will be done monthly on actual basis. In the third month and sixth month, balance payment above actual crane running hours will be released subject to maximum ceiling as per CASE I or CASE II

CASE I : For 240 hours operation of crane per month, payment for 720 hours per quarter will be assured


CASE II : For 120 hours operation of crane per month, payment for 360 hours per quarter will be assured

VIII. Income Tax will be deducted from the bill as per IT rules & GST-TDS will be deducted as per GST rules. Any other taxes as per Income Tax Act or GST Rules or Amendment as applicable shall be liable to be deducted under a specific act if applicable.

IX. The tenderer shall enclose copy of PAN CARD along with the offer.

X. GST amount will be reimbursed after submission of proof of uploading the GST invoices and amount in GST portal.
